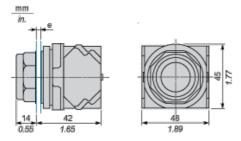

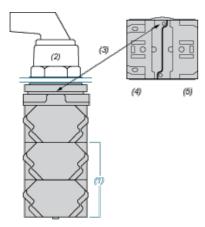

Top and Rear views

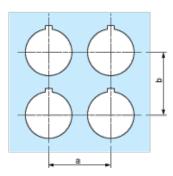
