Schematic:



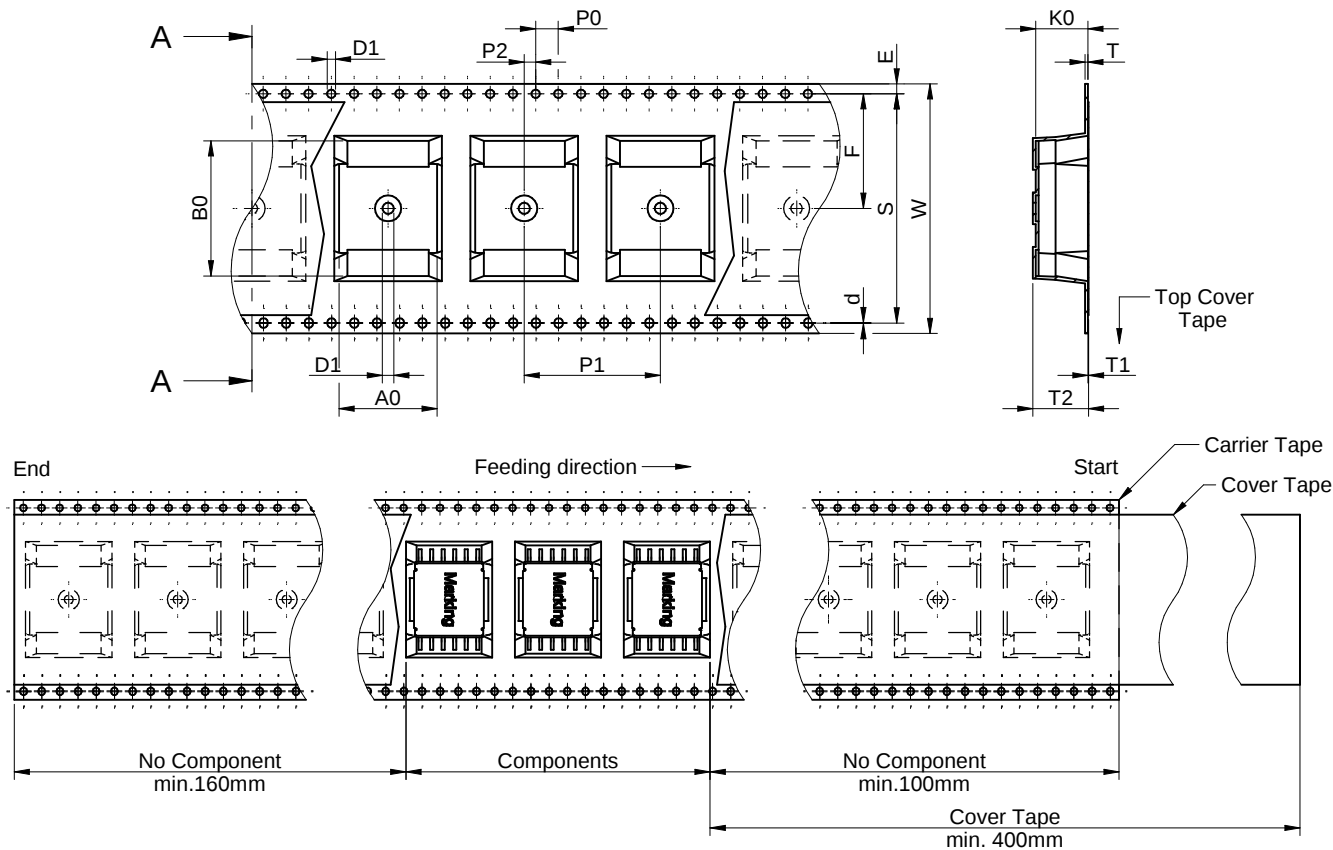
