1. General description

The 74LVC2G34-Q100 provides two buffers.

Inputs can be driven from either 3.3 V or 5 V devices. These features allow the use of these devices in a mixed 3.3 V and 5 V environment.

This device is fully specified for partial power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.

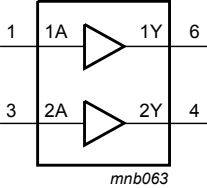


Fig. 1. Logic symbol

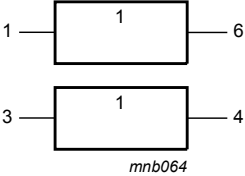


Fig. 2. IEC logic symbol

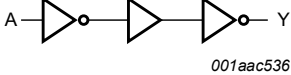


Fig. 3. Logic diagram (one gate)

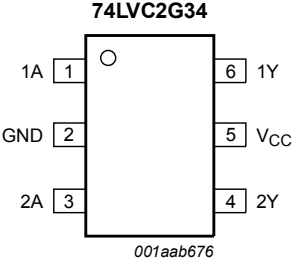


Fig. 4. Pin configuration SOT363 (SC-88) and SOT457 (TSOP6)

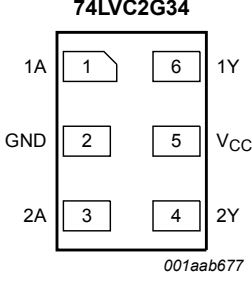


Fig. 5. Pin configuration SOT886 (XSON6)

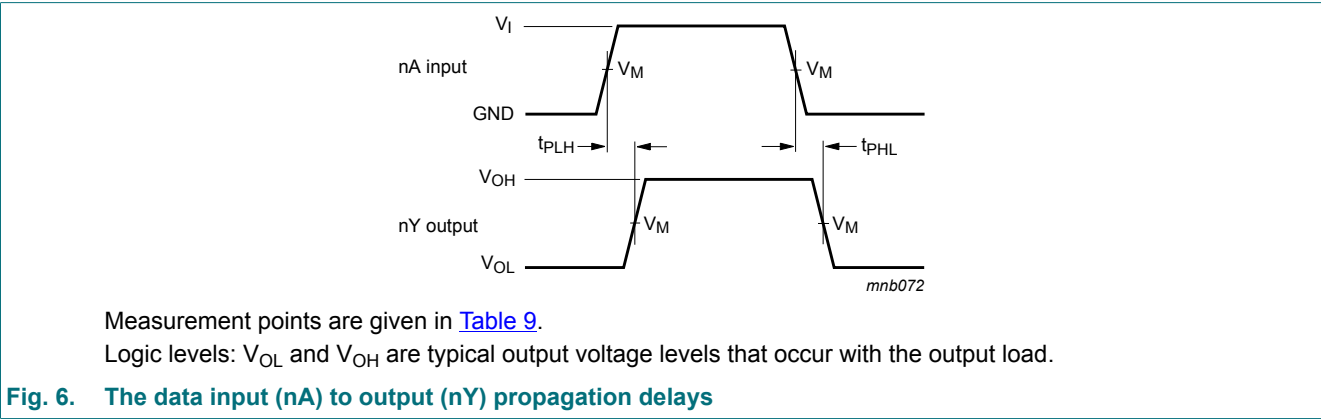
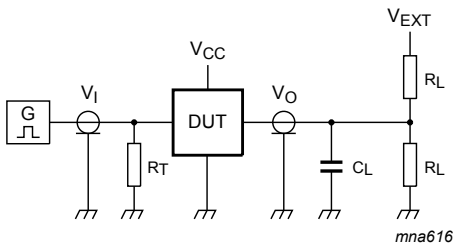

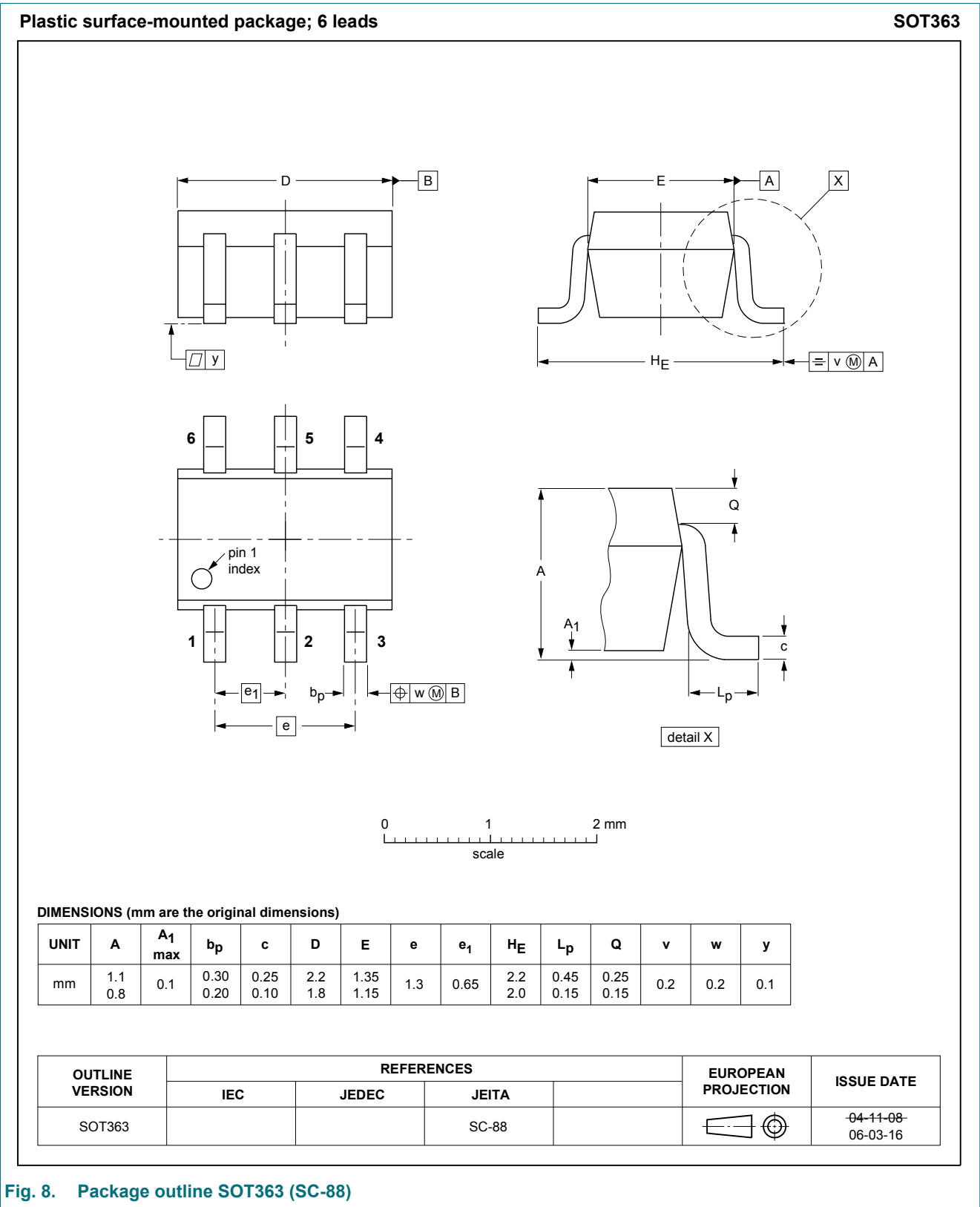


Fig. 8. Package outline SOT363 (SC-88)

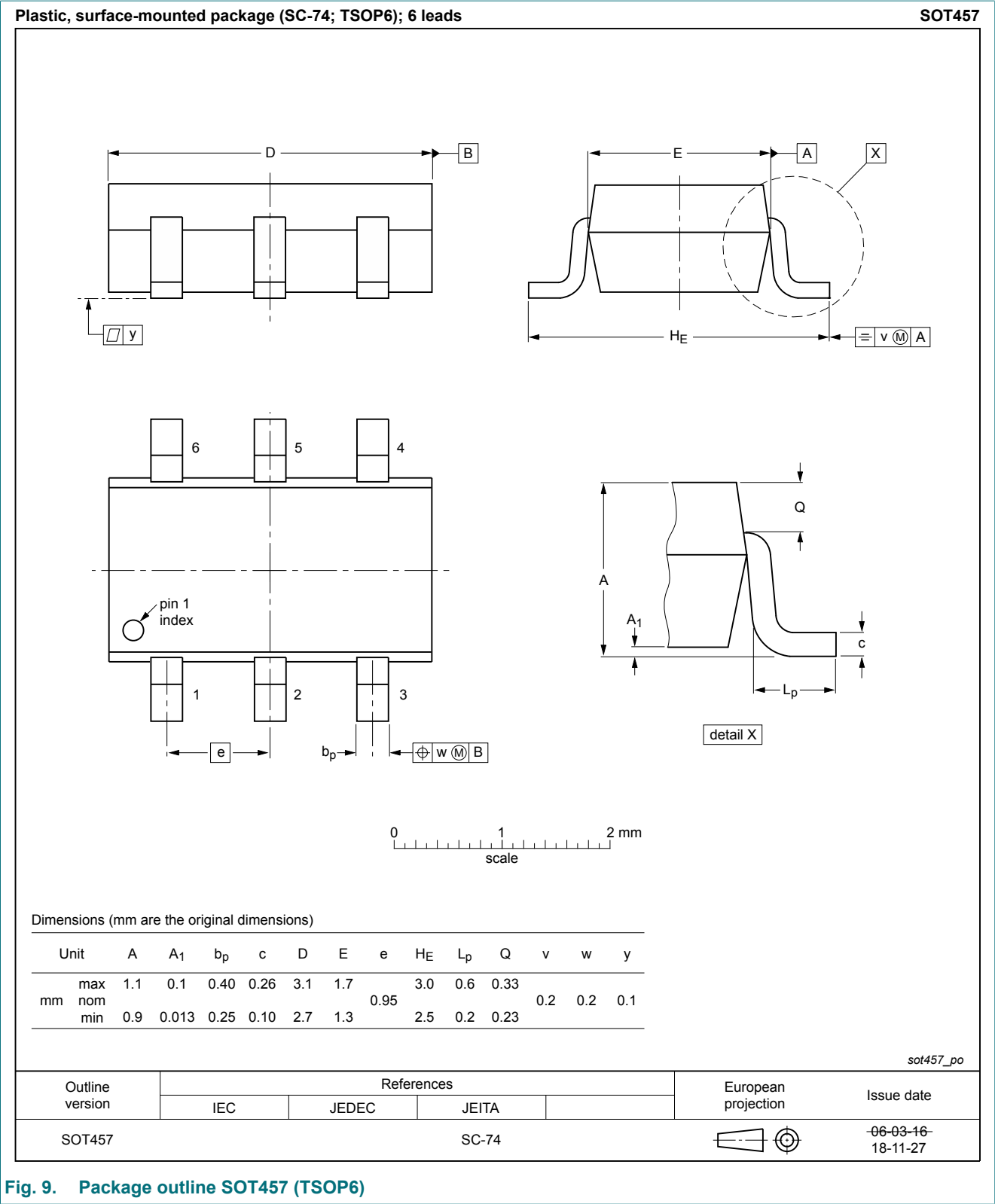
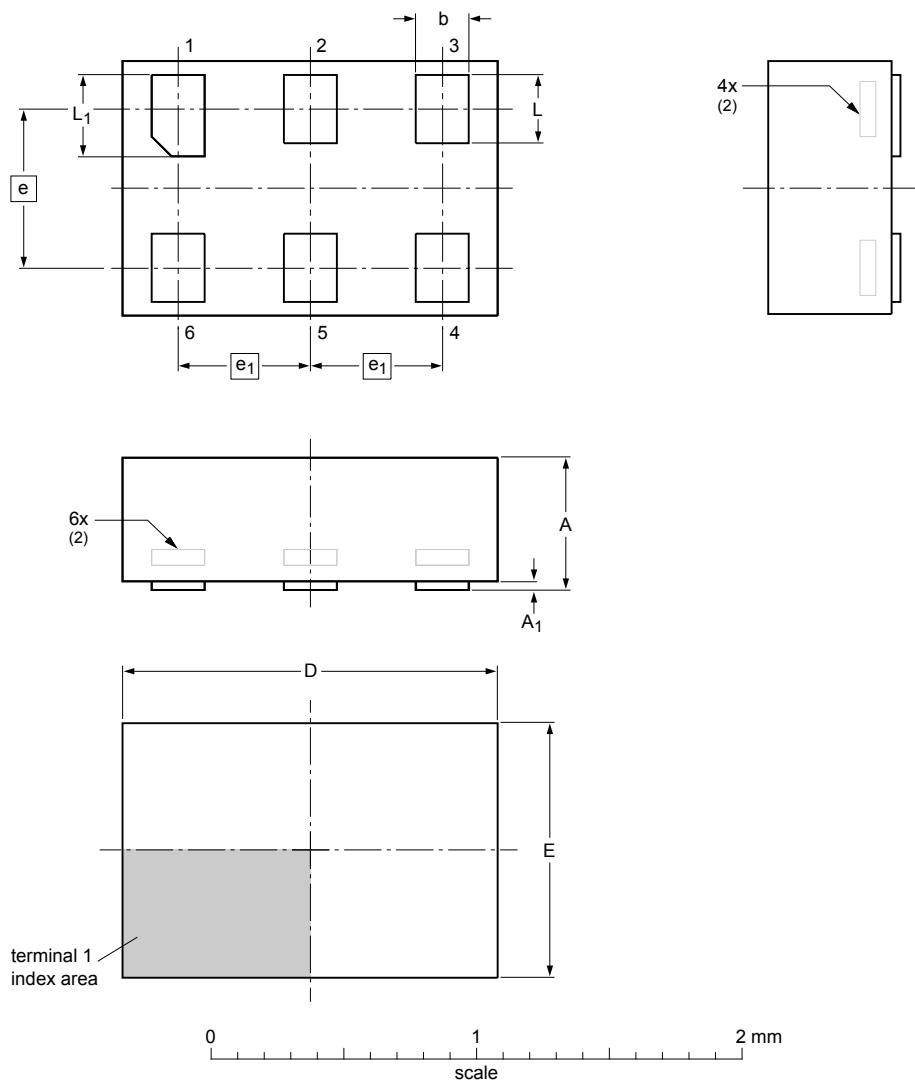


Fig. 9. Package outline SOT457 (TSOP6)
