





Let  $V_{\text{th}}$  be the voltage applied between gate and source that causes the drain current ( $I_D$ ) to be low (1mA for the SSM3K37CT). Then, for normal switching operation,  $V_{GS(\text{on})}$  must be higher than  $V_{\text{th}}$ , and  $V_{GS(\text{off})}$  must be lower than  $V_{\text{th}}$ . This relationship can be expressed as:  $V_{GS(\text{off})} < V_{\text{th}} < V_{GS(\text{on})}$ .






