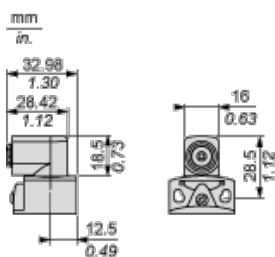

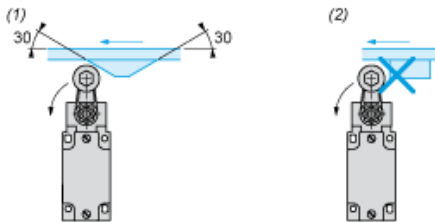
Position of Cable Gland

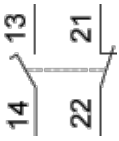
Setting-up with Head ZCE01 and ZCE09

- (2) Tightening torque (Min : 0.8) (Max : 1.2)

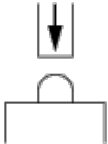
Wiring Diagram
