




F Typical Impedance Characteristics:





After the potting material is cured, the ferrite body and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Cleaning agents that are used to clean the application might damage or change the characteristics of the component, body, pins or termination.
