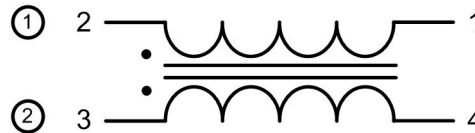
**B Recommended hole pattern: [mm]**

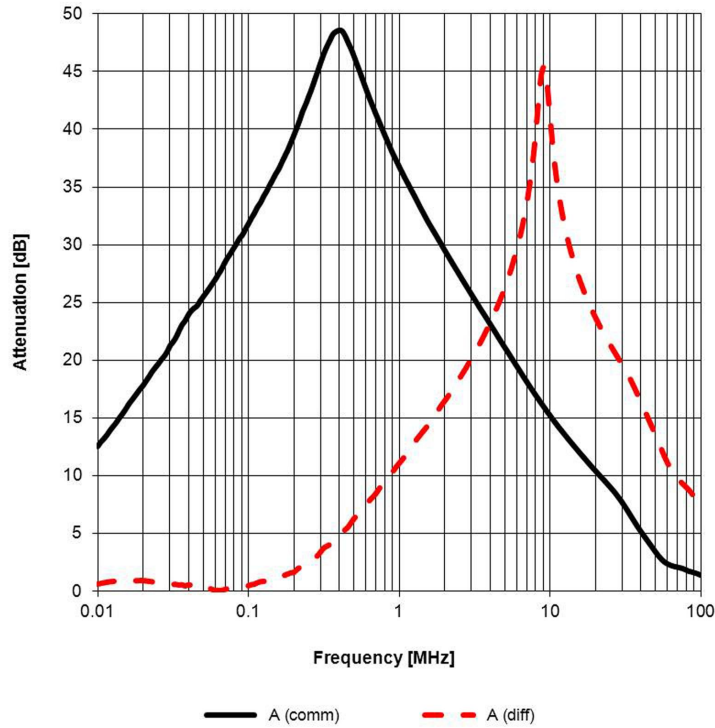

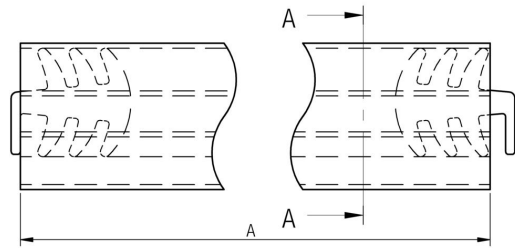
**F Typical Insertion Loss Characteristics:**



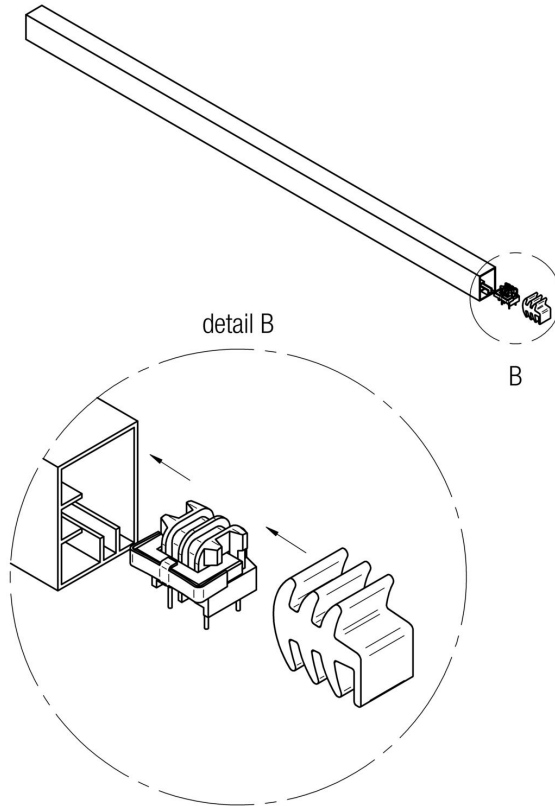
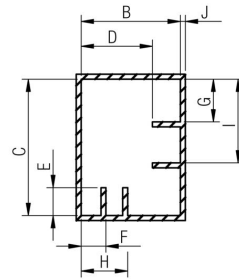
