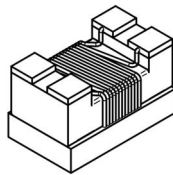

Differential Mode

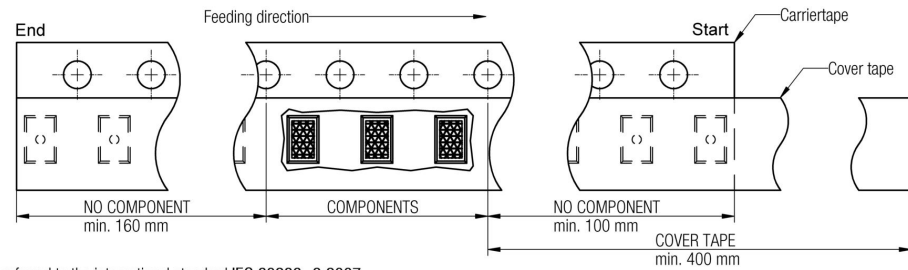
