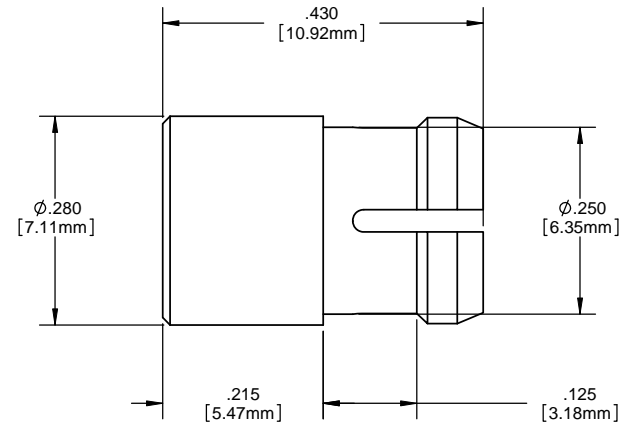
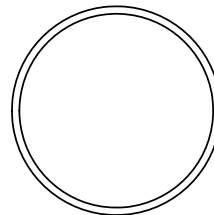
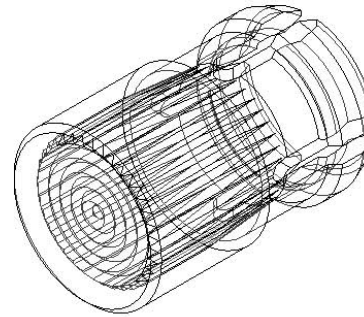

1. **MOUNTING:** Mounts in a  $\phi .250 \pm .002$  [ $\phi 6.35\text{mm} \pm .05$ ] panel hole on .375 [9.5mm] centers. Panel thickness .063 [1.6mm] to .125 [3.17mm]. Panel hole should be deburred, but not chamfered.
2. **ASSEMBLY:** Insert lens through panel hole, and insert LED into lens.
3. **MATERIAL:** Polycarbonate, UL 94-V2

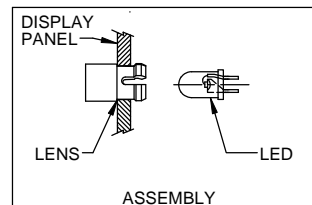
