- * It is not recommended that a lubricator be used with this unit, or any DMC pneumatic tool. This unit is designed to work with DMC pneumatic tools whether the foot press is used or not.
- * All Crimp Tools, Positioning Heads,
 Bench Mounts, Gages and Foot Valves must
 be ordered separately by part number.


INSTALLATION

The unit should be installed in—line between air source & equipment being regulated. The air supply should be attached to the inlet of the regulator. Note the air flow arrow stamped on the side of the regulator. When the air supply fitting is threaded into the regulator use Teflon thread sealing tape. Attach the hose going to the tool or foot press into the outlet of the filter. Be sure to use Teflon thread sealing tape when attaching the fitting.

OPERATION

The air pressure is adjusted by turning the knob on the bottom of the regulator. The knob must be pulled out for it to be able to be adjusted. Once the desired pressure is achieved push the knob in to lock in the setting.

Periodically, the plastic bowl in the bottom of filter will need to be emptied. To do this, push in the metal stem in the bottom of the bowl. The water will then drain out. The frequency of the need for this will depend upon operating conditions, and the condition of the air supply.
