

Note 1: If a reverse bias is applied between gate and source, this device enters $V_{(BR)DSX}$ mode. Note that the drain-source breakdown voltage is lowered in this mode.

Note 2: Let V_{th} be the voltage applied between gate and source that causes the drain current (I_D) to below (-100 μA for this device). Then, for normal switching operation, $V_{GS(ON)}$ must be higher than V_{th} , and $V_{GS(OFF)}$ must be lower than V_{th} . This relationship can be expressed as: $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$.

Take this into consideration when using the device.




Fig. 5.3.1 Switching Time Test Circuit





Fig. 5.3.2 Input Waveform/Output Waveform









Fig. 7.1 I_D - V_{DS} Fig. 7.2 I_D - V_{GS} Fig. 7.3 $R_{DS(ON)}$ - V_{GS} Fig. 7.4 $R_{DS(ON)}$ - V_{GS} Fig. 7.5 $R_{DS(ON)}$ - T_a Fig. 7.6 $R_{DS(ON)}$ - I_D
