1. General description

The 74HC132-Q100; 74HCT132-Q100 is a quad 2-input NAND gate with Schmitt-trigger inputs. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} . Schmitt trigger inputs transform slowly changing input signals into sharply defined jitter-free output signals.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.

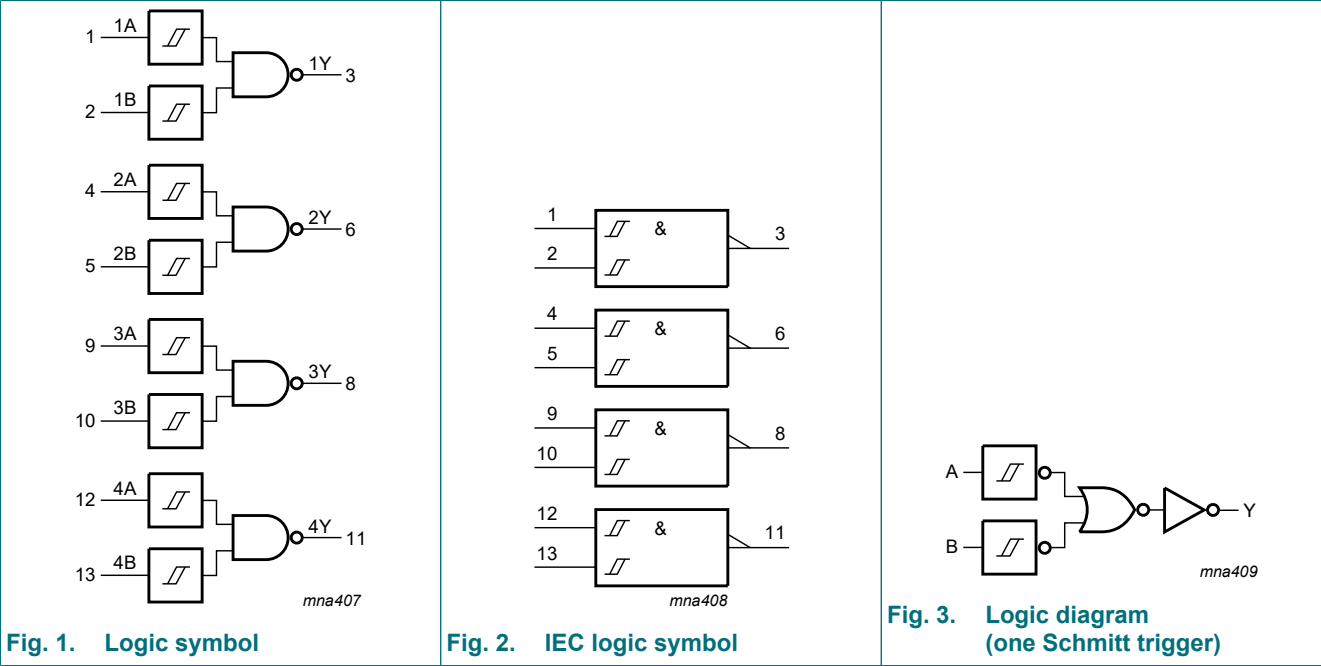

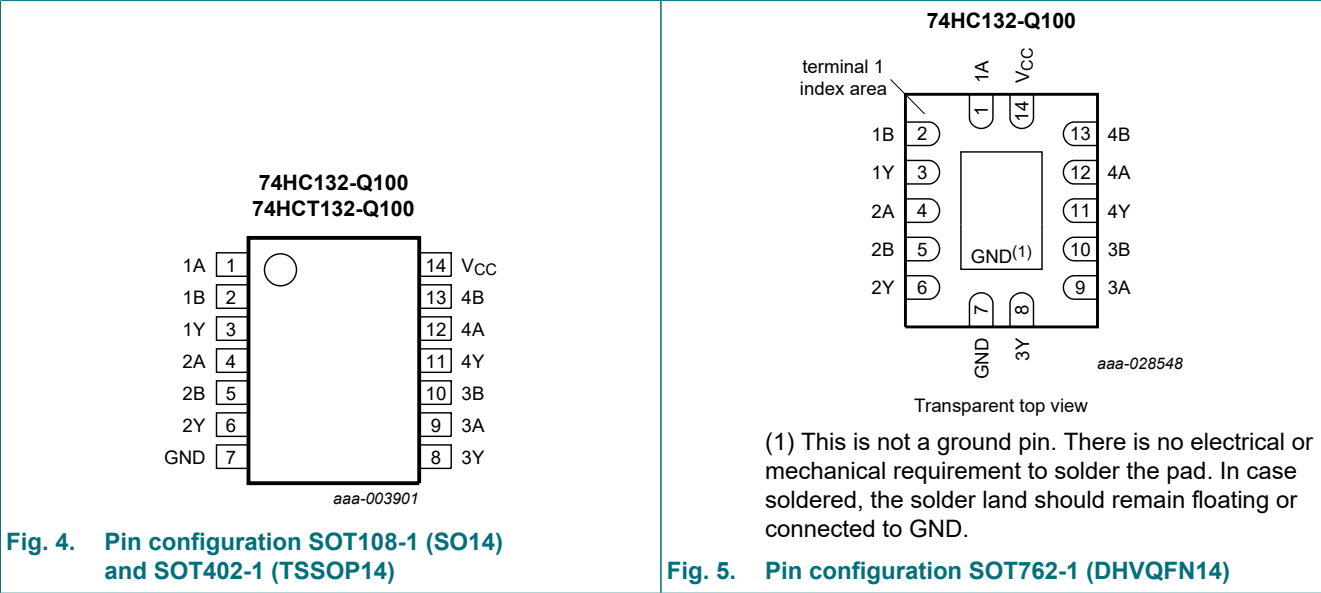

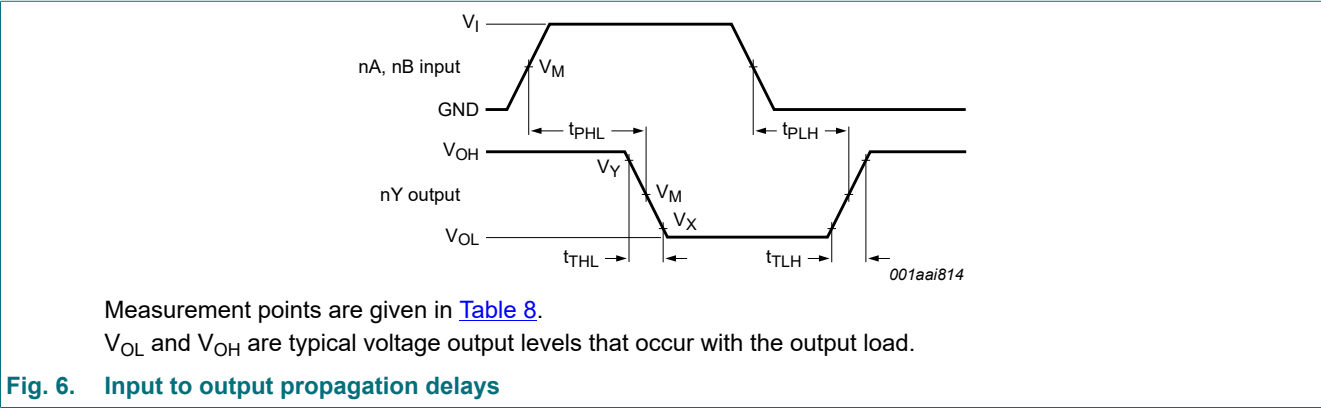

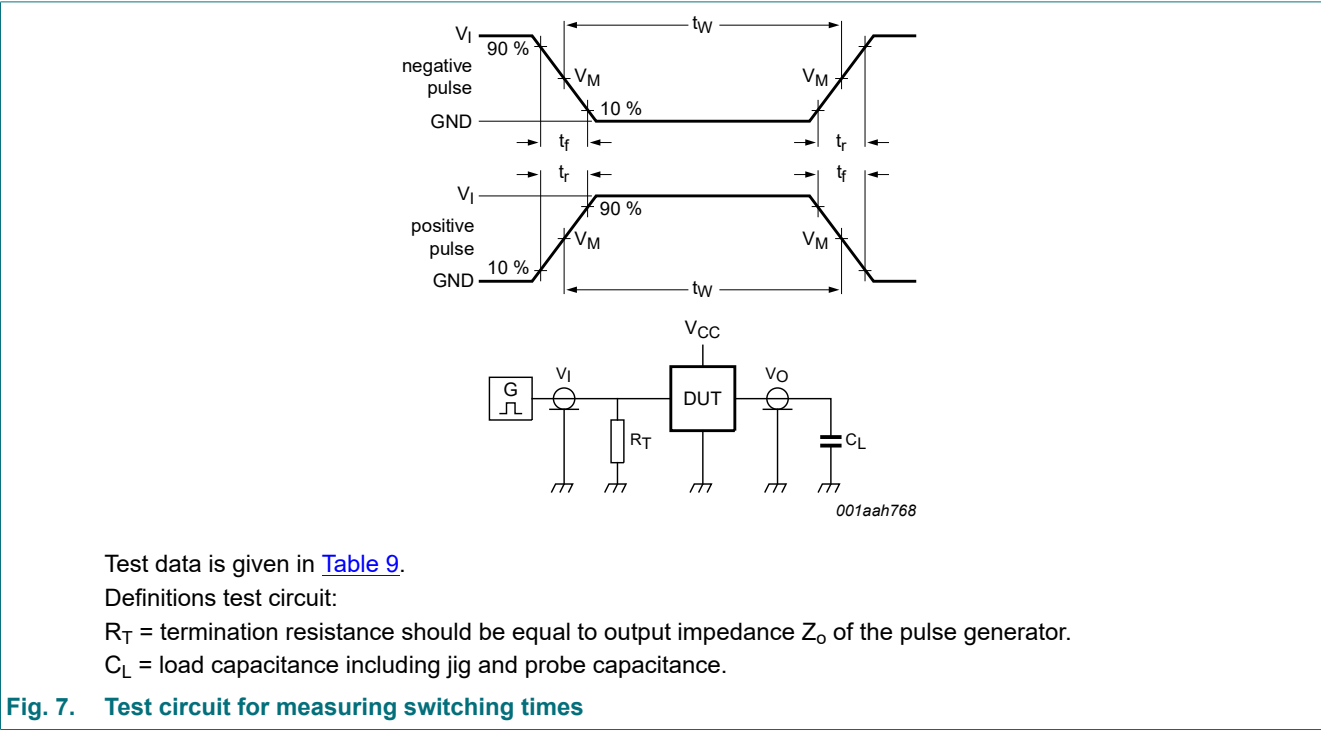

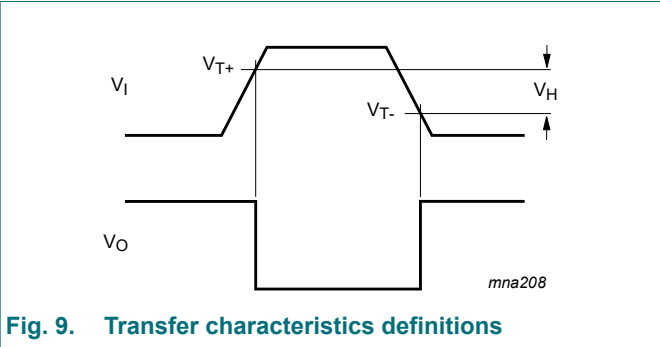

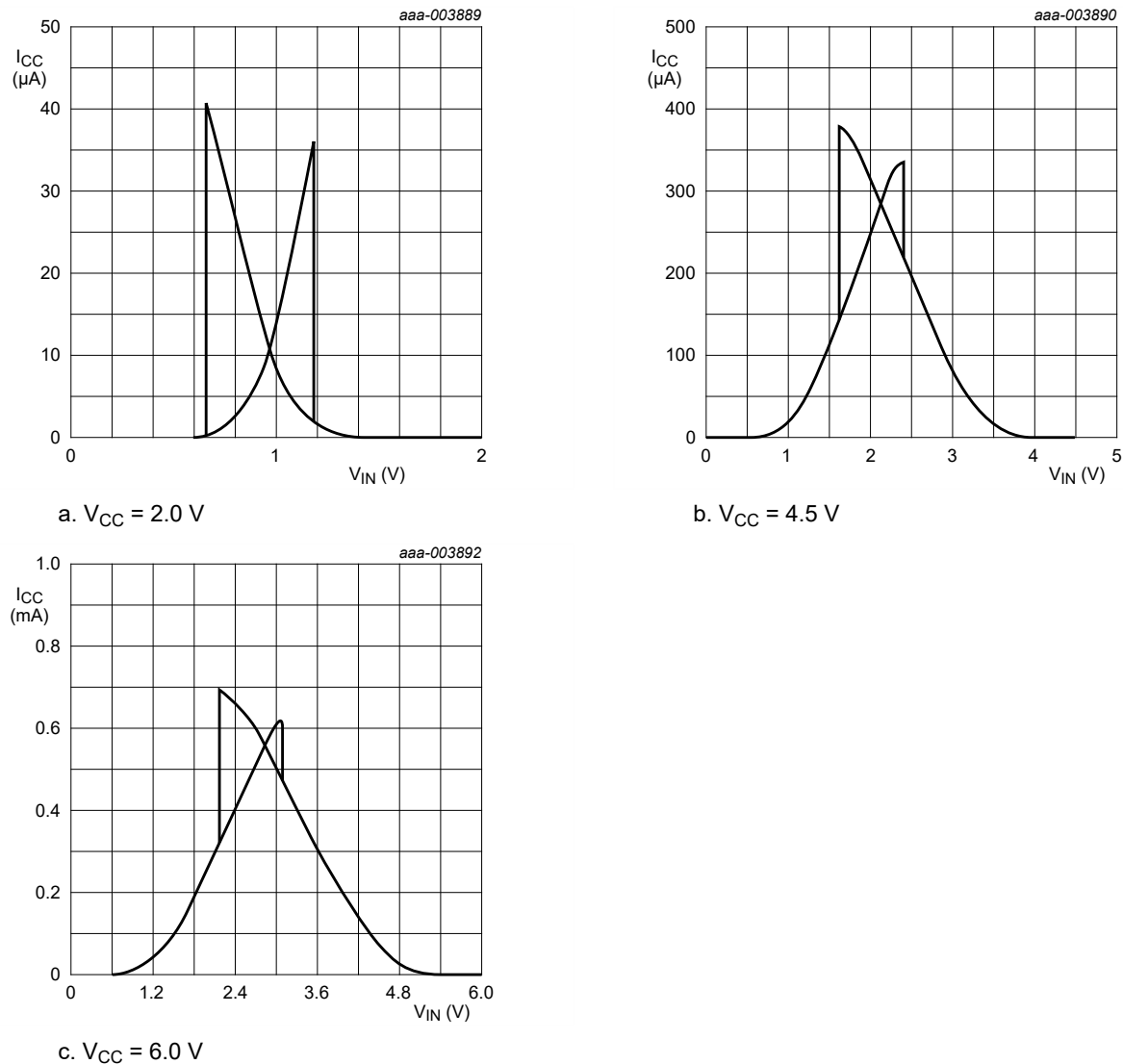


Fig. 10. Typical 74HC132-Q100 transfer characteristics

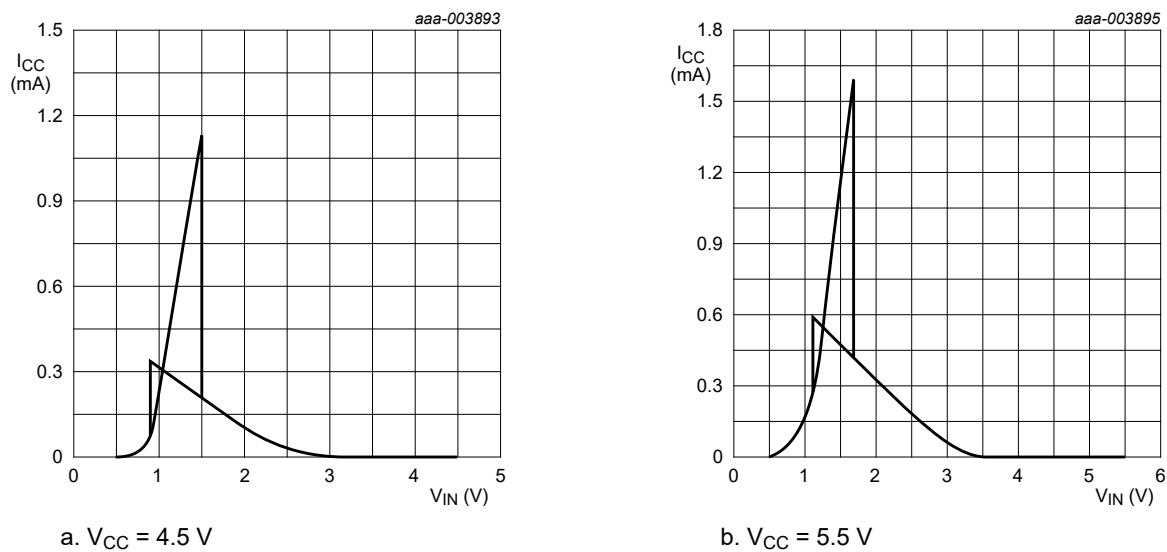


Fig. 11. Typical 74HCT132-Q100 transfer characteristics

13. Application information

The slow input rise and fall times cause additional power dissipation, this can be calculated using the following formula:

$$P_{\text{add}} = f_i \times (t_r \times \Delta I_{\text{CC(AV)}} + t_f \times \Delta I_{\text{CC(AV)}}) \times V_{\text{CC}} \text{ where:}$$

P_{add} = additional power dissipation (μW);

f_i = input frequency (MHz);

t_r = rise time (ns); 10 % to 90 %;

$\Delta I_{\text{CC(AV)}}$ = average additional supply current (μA).

t_f = fall time (ns); 90 % to 10 %;

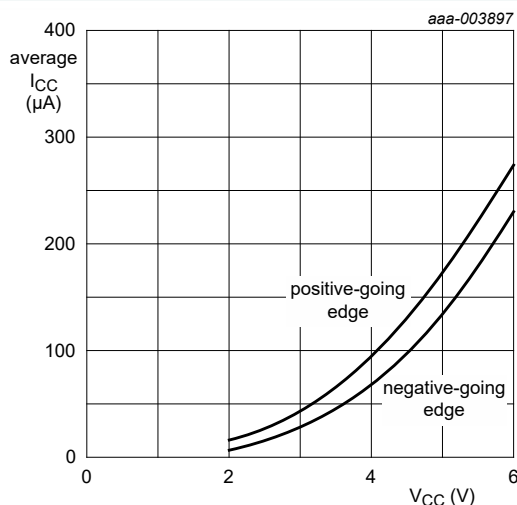


Fig. 12. Average additional supply current as a function of V_{CC} for 74HC132-Q100; linear change of V_i between $0.1V_{\text{CC}}$ to $0.9V_{\text{CC}}$.

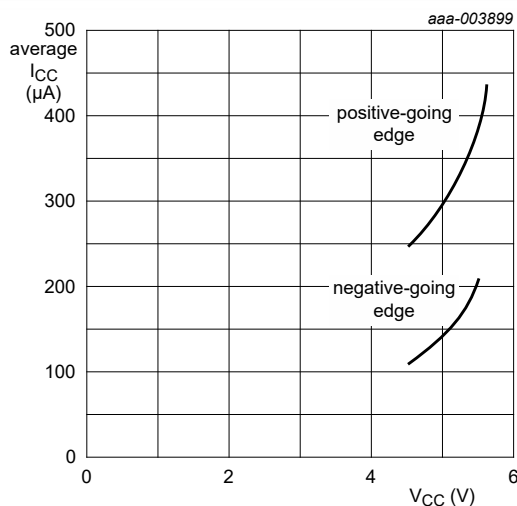
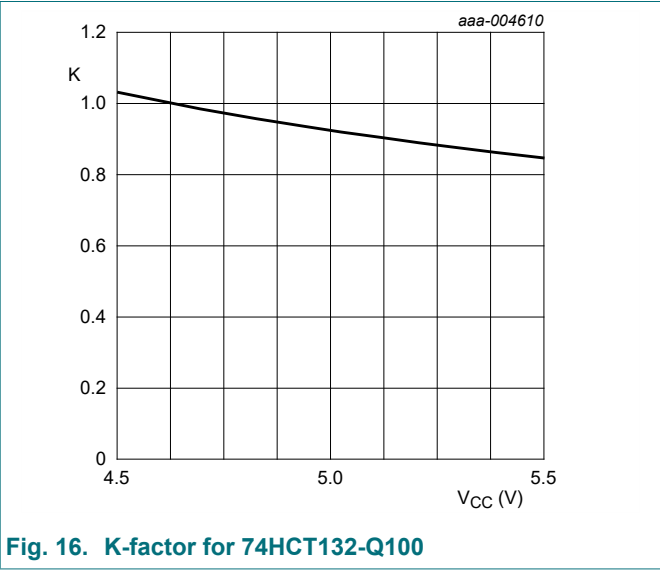
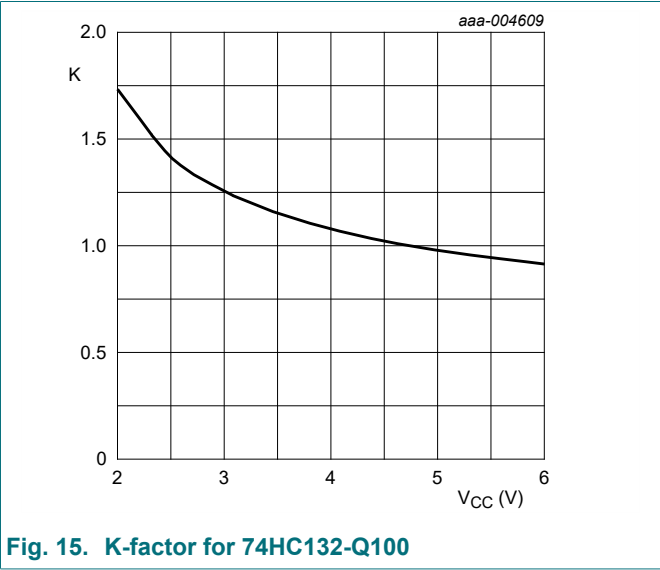
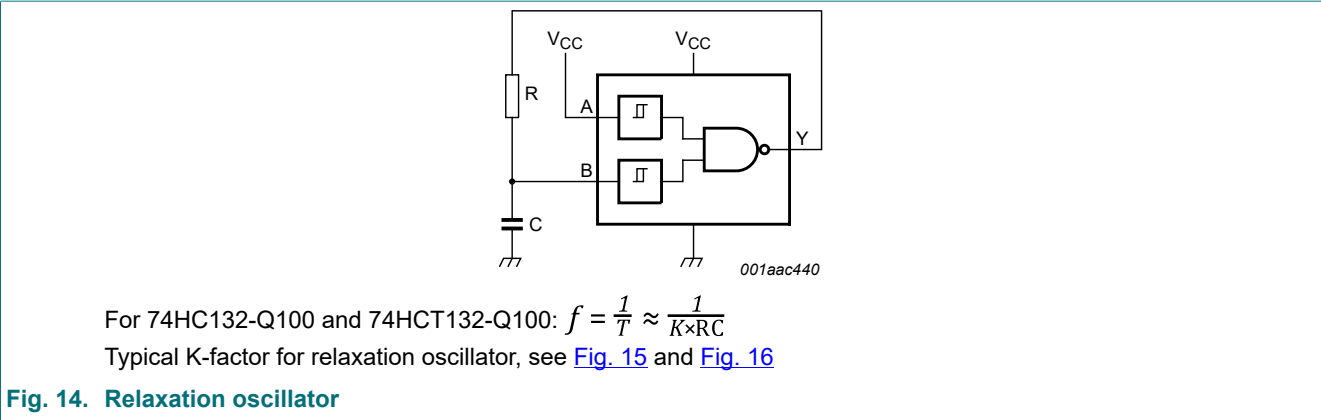


Fig. 13. Average additional supply current as a function of V_{CC} for 74HCT132-Q100; linear change of V_i between $0.1V_{\text{CC}}$ to $0.9V_{\text{CC}}$.

Average $\Delta I_{\text{CC(AV)}}$ differs with positive or negative input transitions, as shown in [Fig. 12](#) and [Fig. 13](#).

An example of a relaxation circuit using the 74HC132-Q100; 74HCT132-Q100 is shown in [Fig. 14](#).

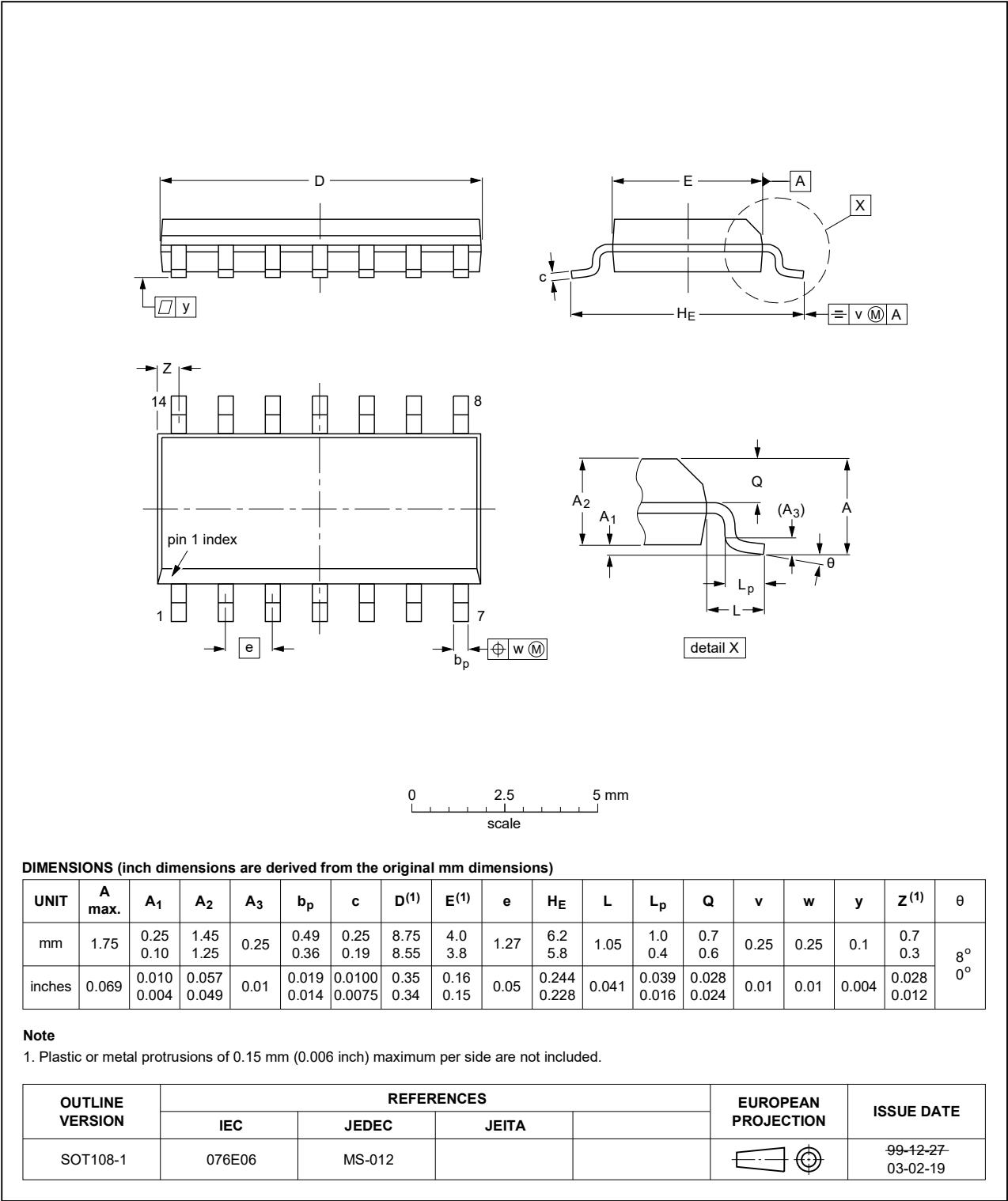


Fig. 17. Package outline SOT108-1 (SO14)

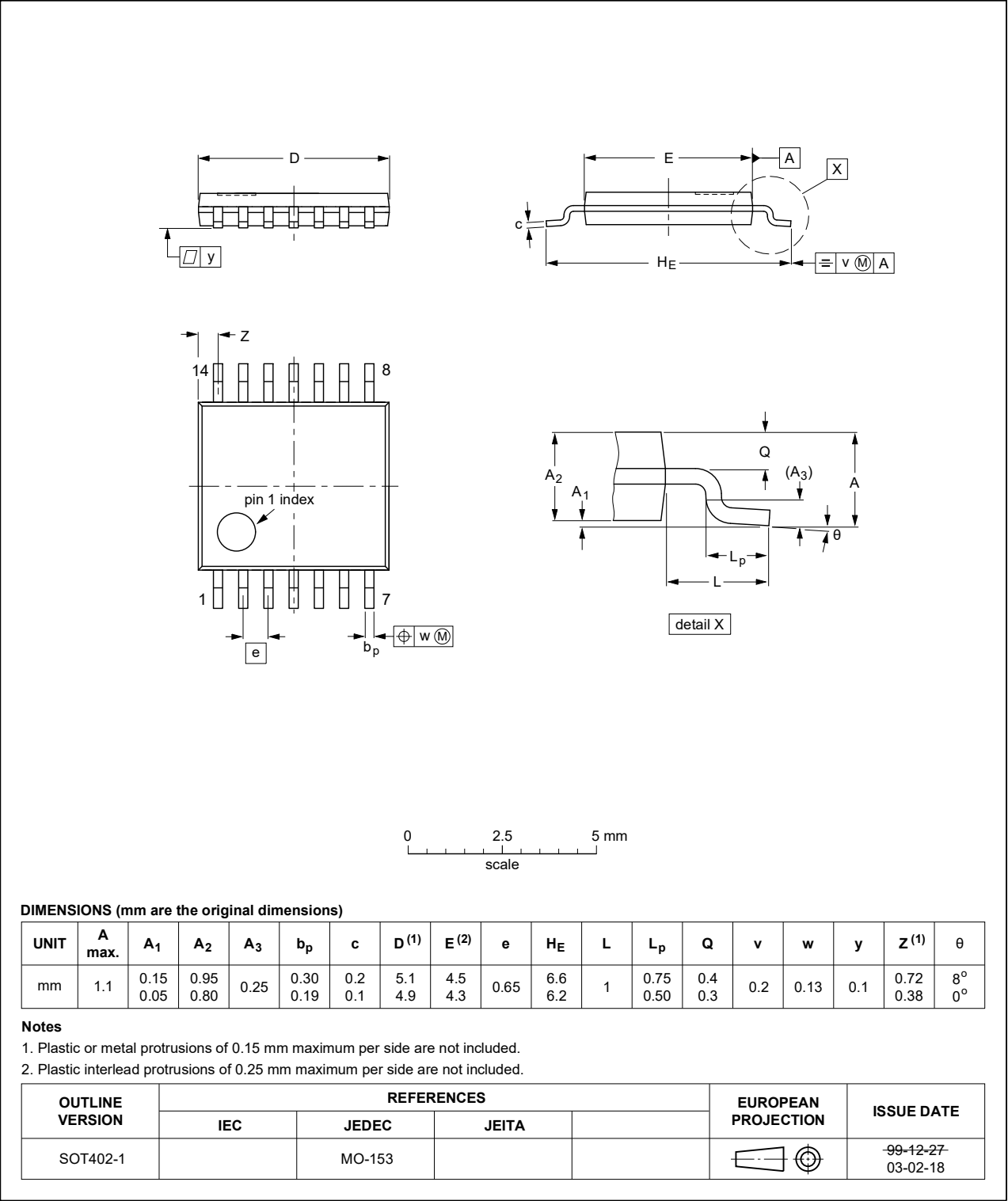


Fig. 18. Package outline SOT402-1 (TSSOP14)

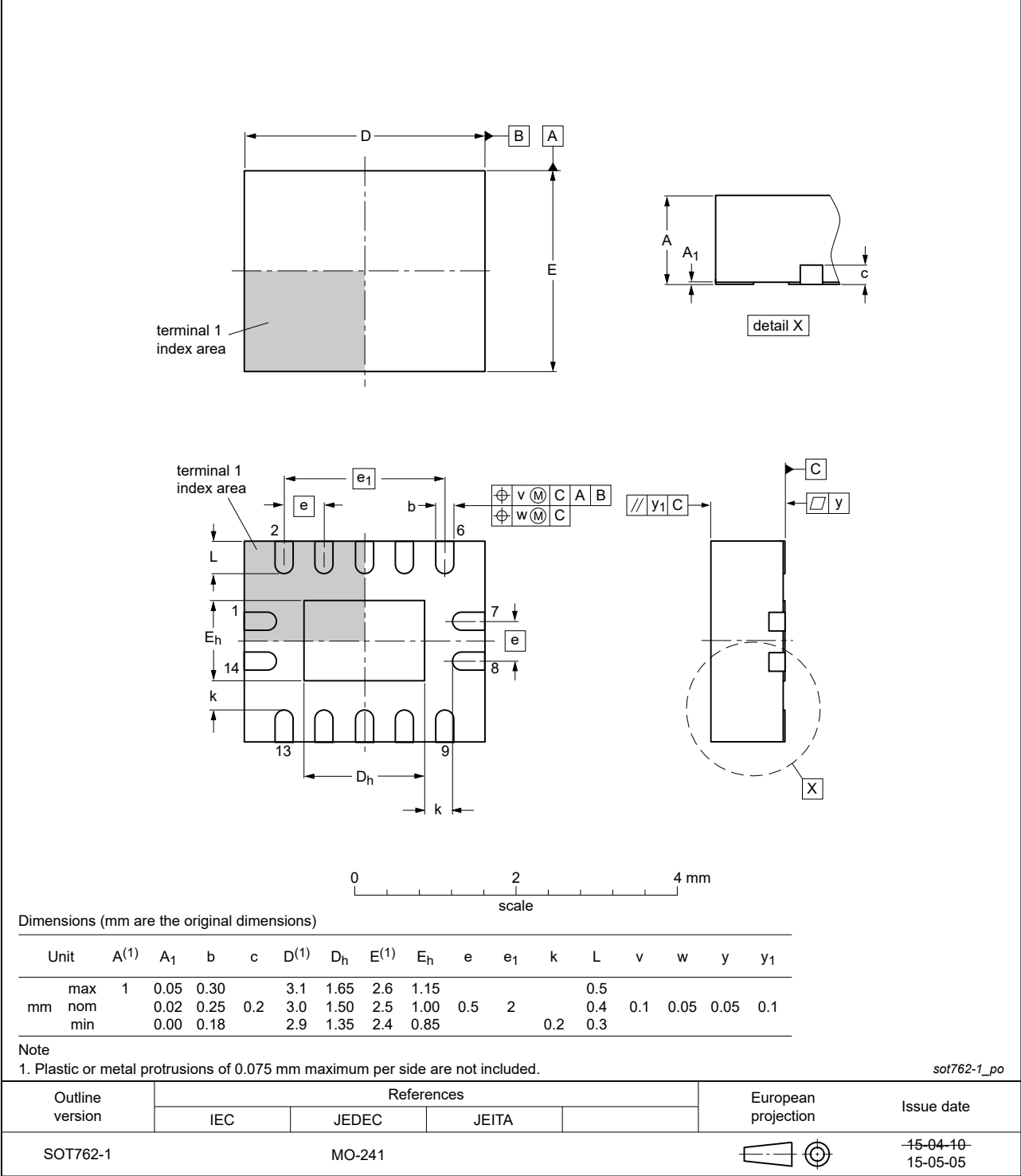


Fig. 19. Package outline SOT762-1 (DHVQFN14)
