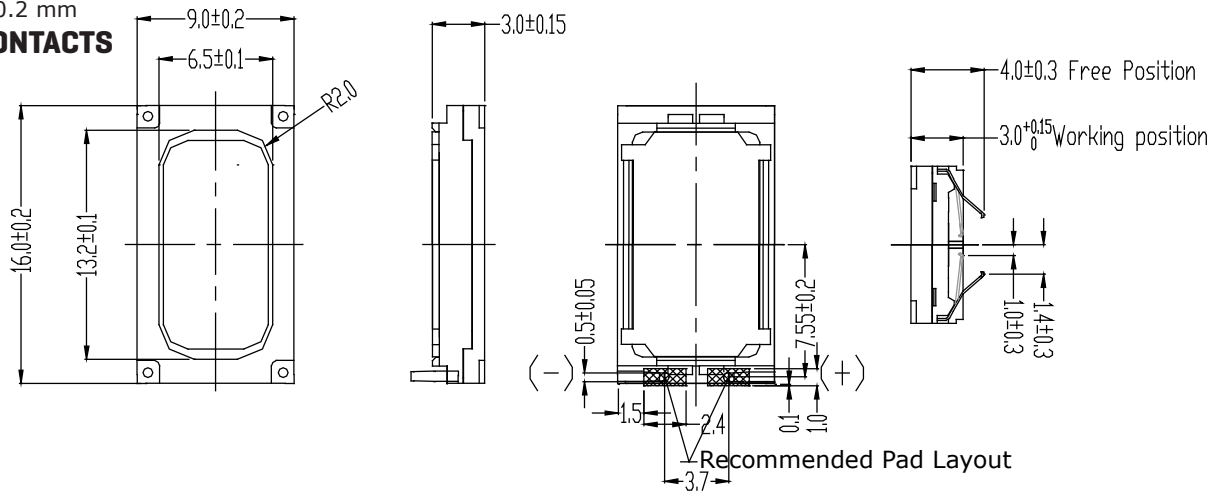

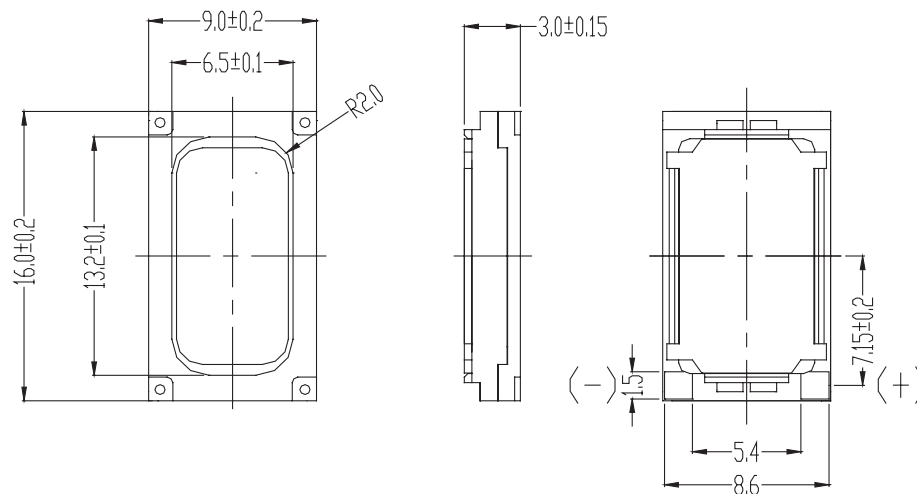

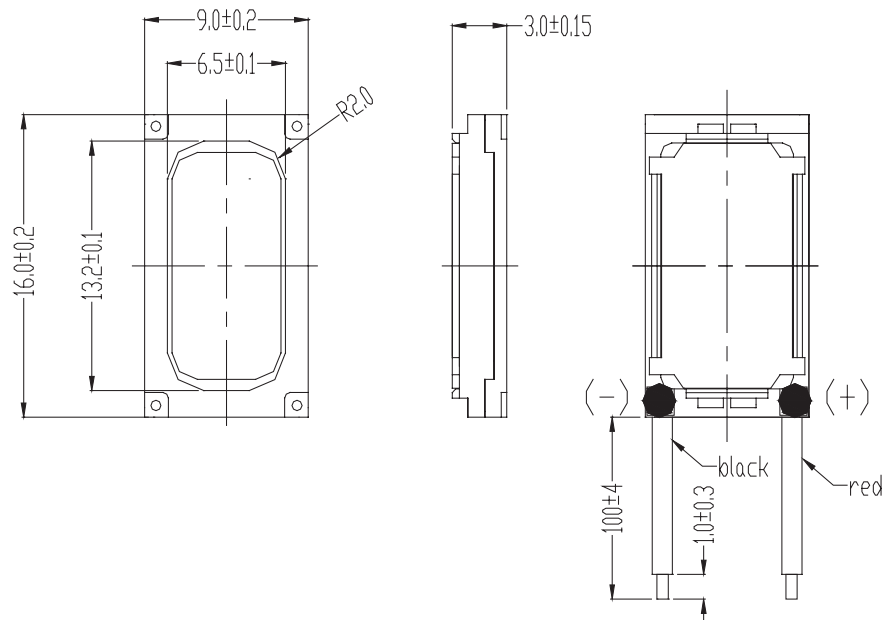


SOLDER PADS



WIRE LEADS

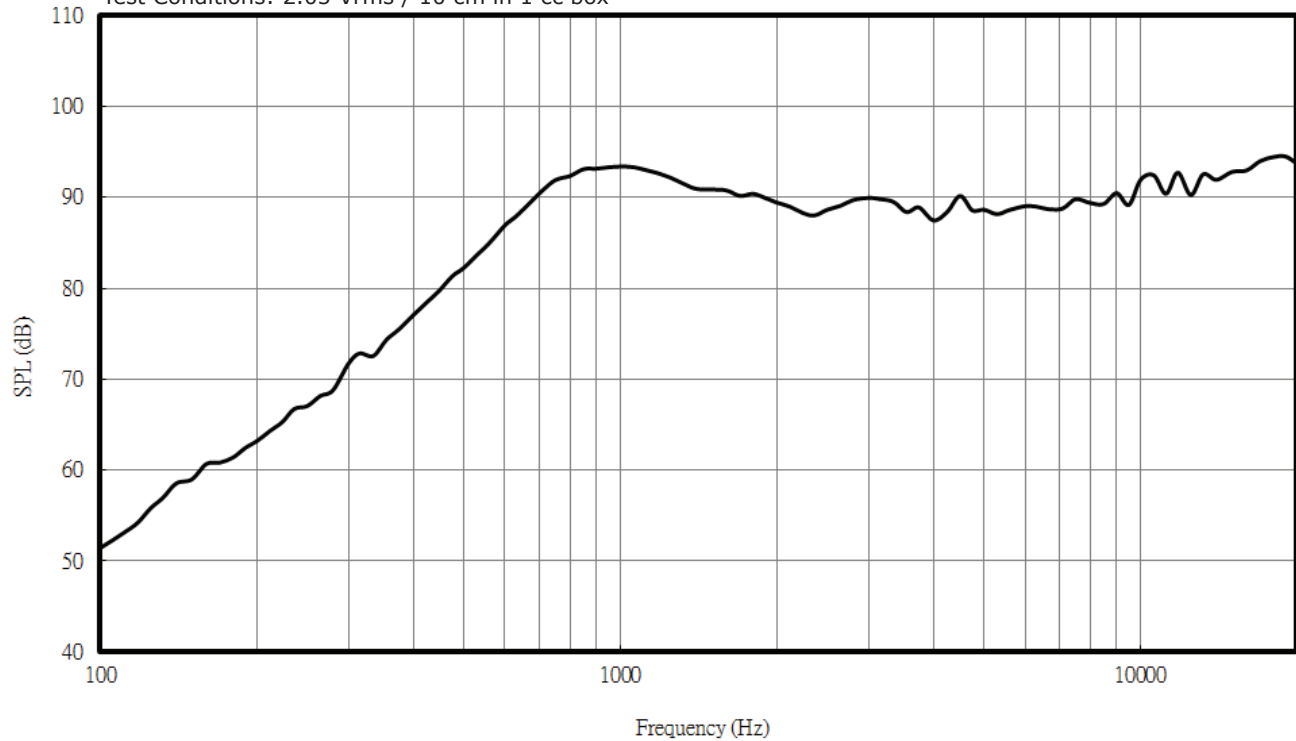

RESPONSE CURVES

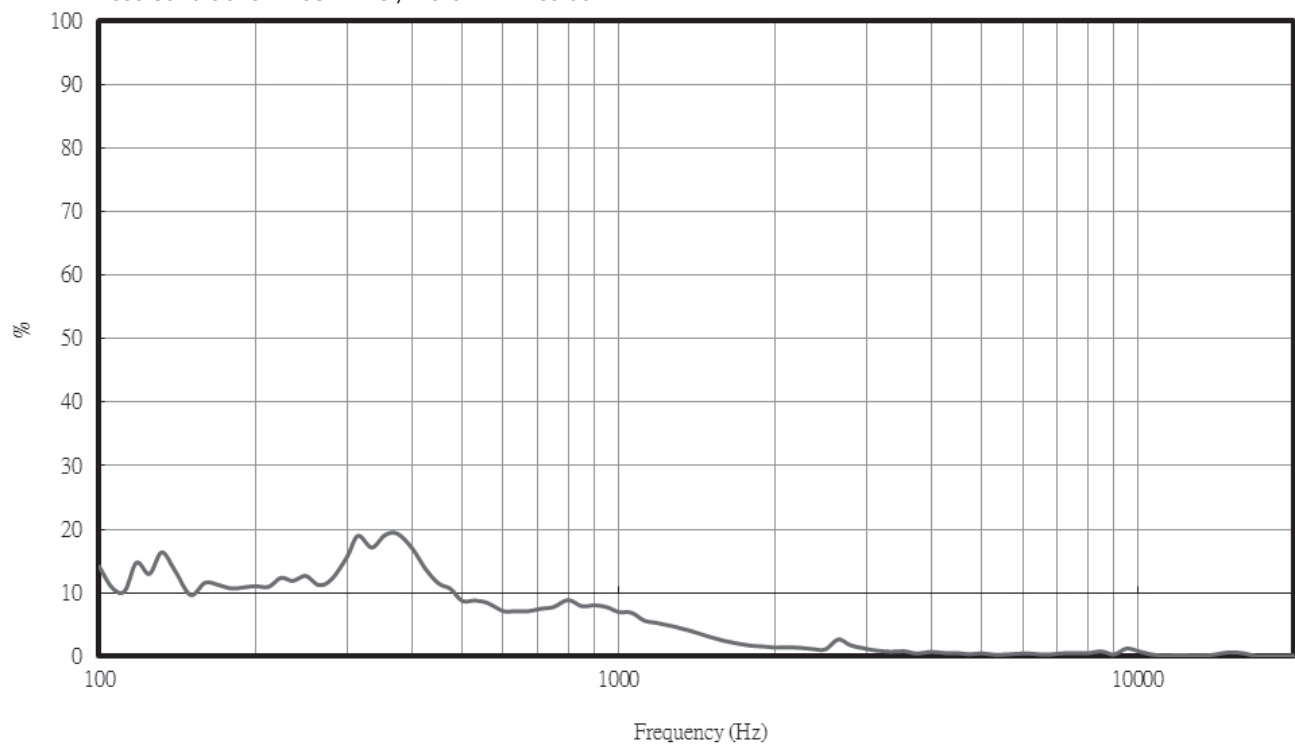
Frequency Response Curve

Total Harmonic Distortion Curve

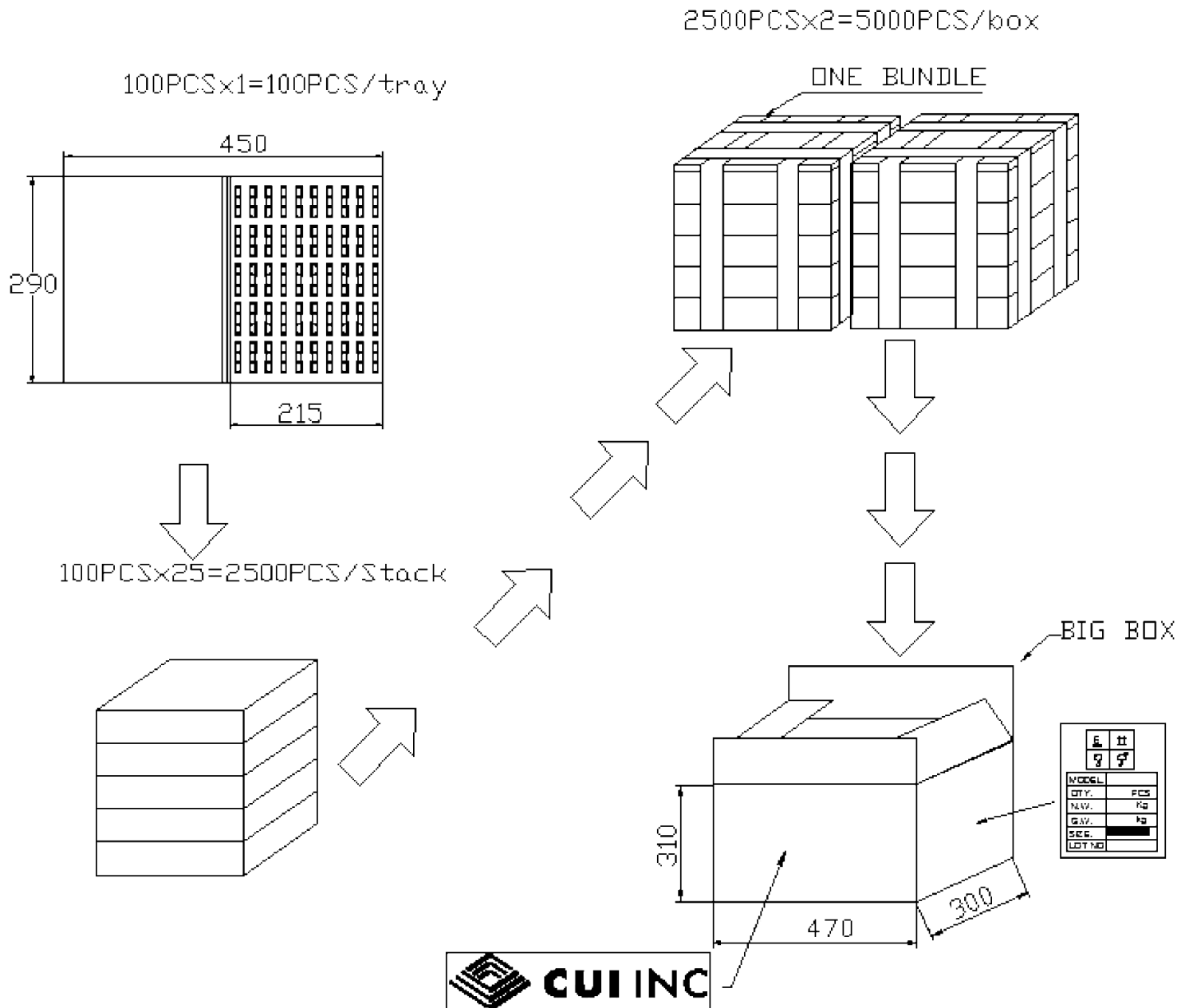
