




Fig. 1 - Maximum Forward Voltage Drop Characteristics




Fig. 2 - Typical Peak Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage





Fig. 4 - Maximum Average Forward Current vs.

Fig. 5 - Maximum Average Forward Dissipation vs. Average Forward Current




Fig. 6 - Maximum Peak Surge Forward Current vs.

DIMENSIONS in millimeters (inches)












