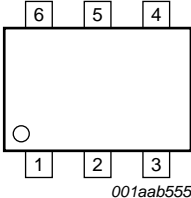
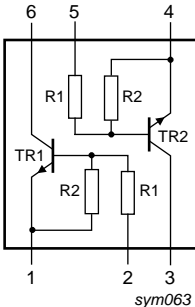

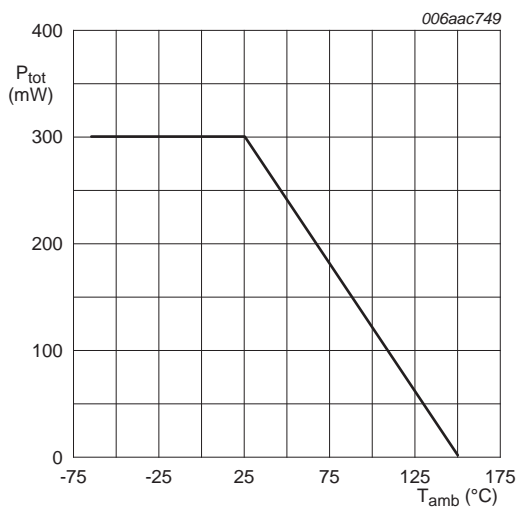

**Fig 1. Per device: Power derating curve for SOT363 (SC-88) and SOT666**

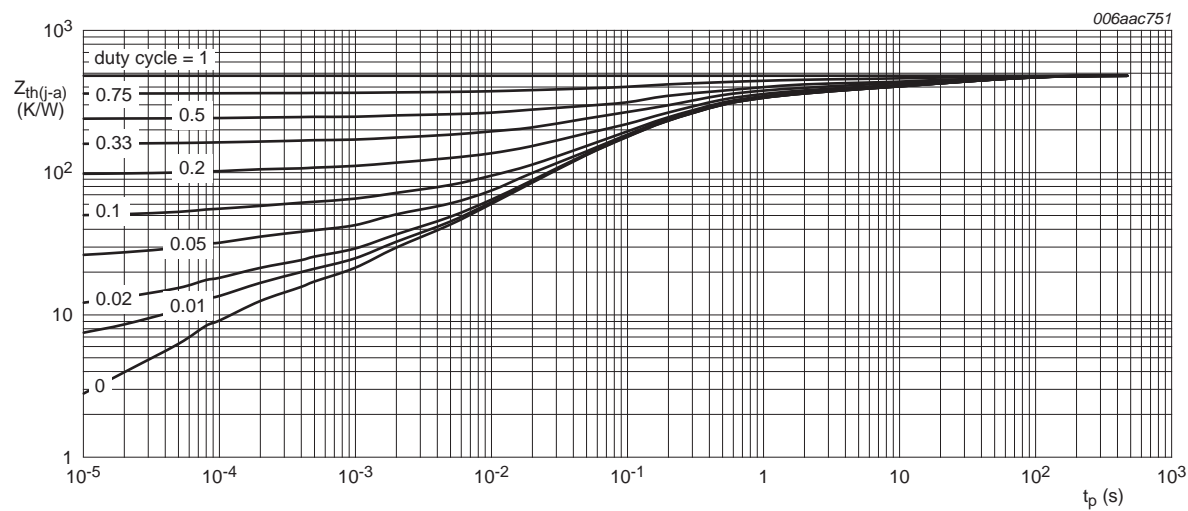

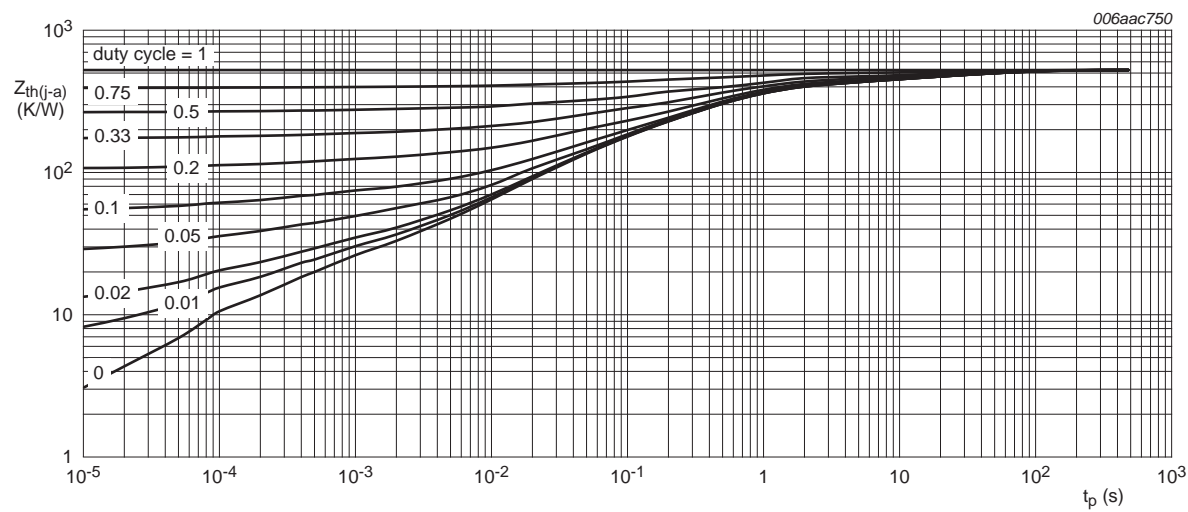

Fig 3. Per transistor: Transient thermal impedance from junction to ambient as a function of pulse duration for PUMH13 (SOT363); typical values

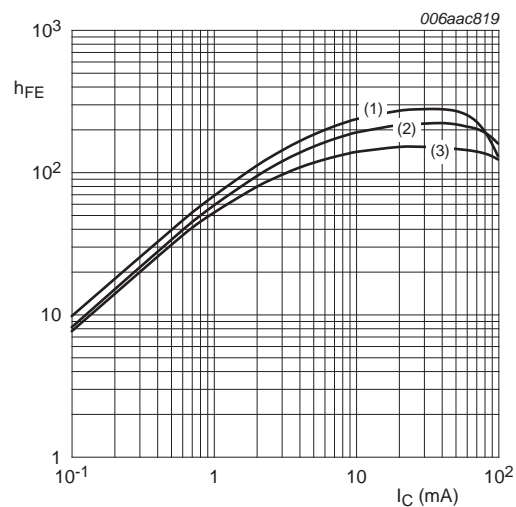

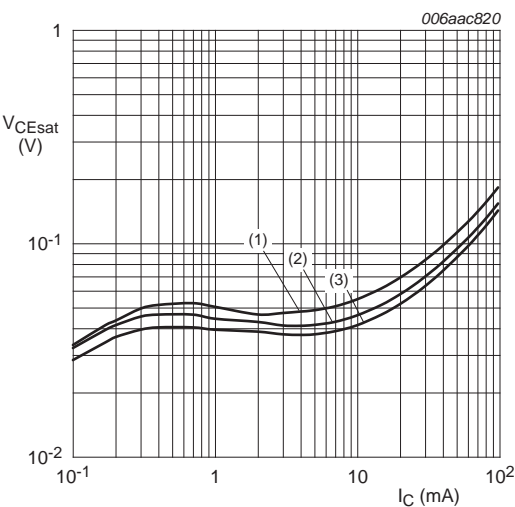

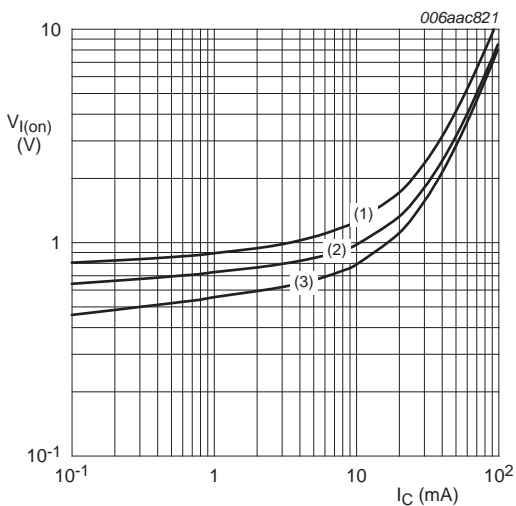

Fig 4. DC current gain as a function of collector current; typical values



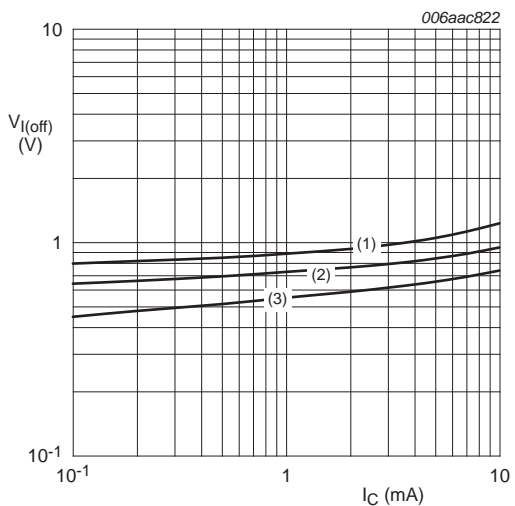

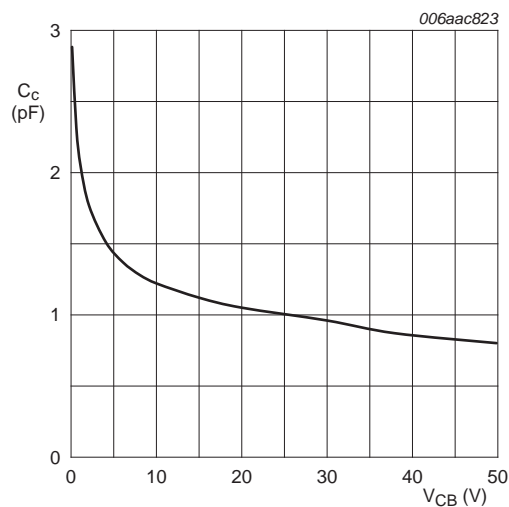
Fig 6. On-state input voltage as a function of collector current; typical values

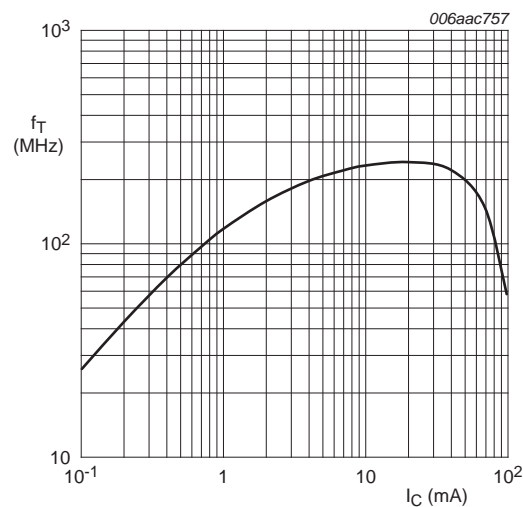
Fig 7. Off-state input voltage as a function of collector current; typical values

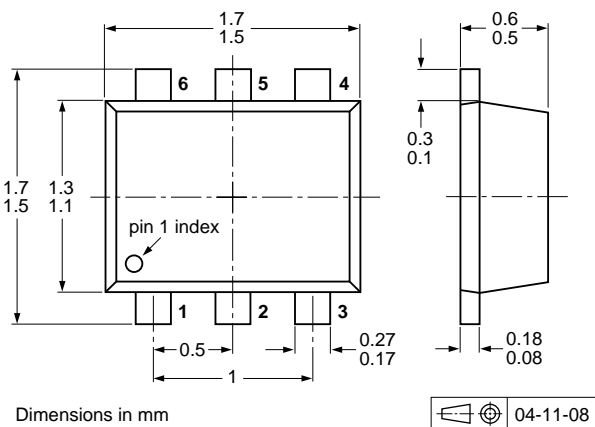


Fig 10. Package outline PEMH13 (SOT666)

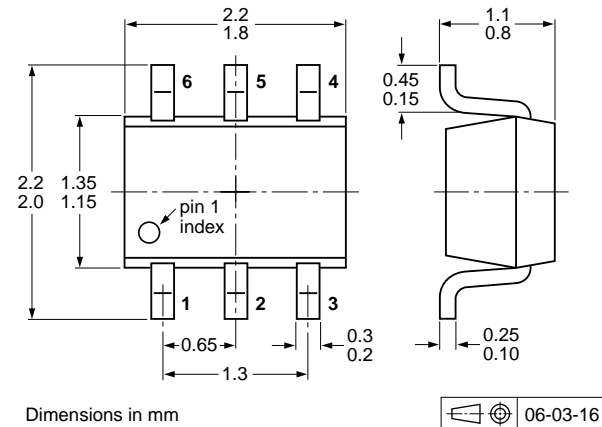


Fig 11. Package outline PUMH13 (SOT363)

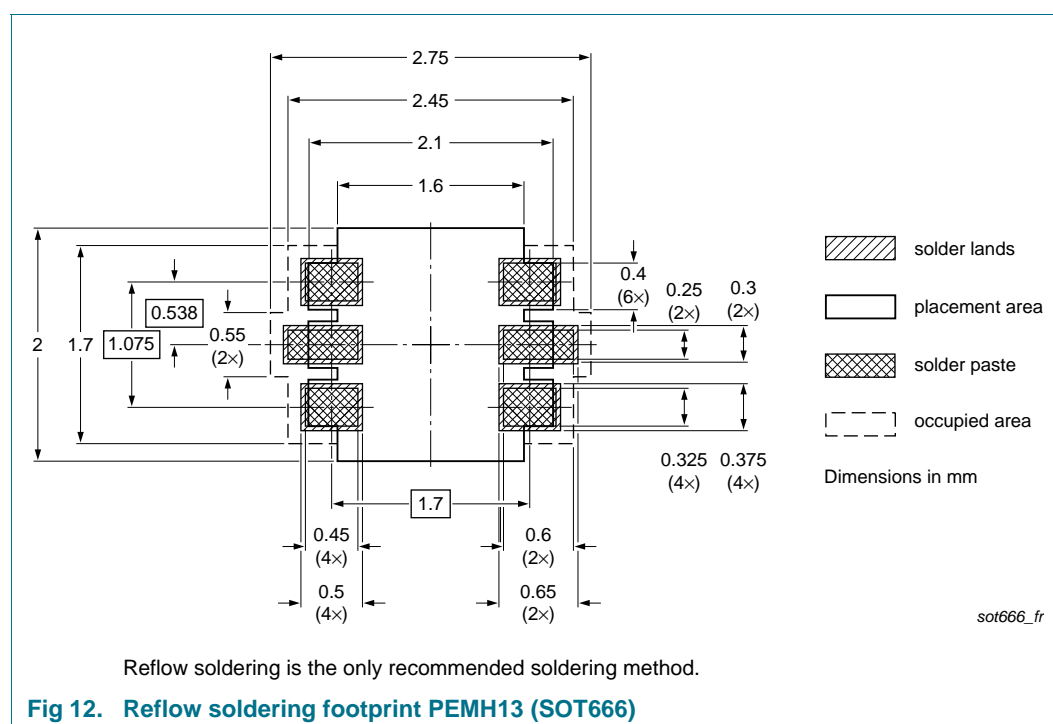

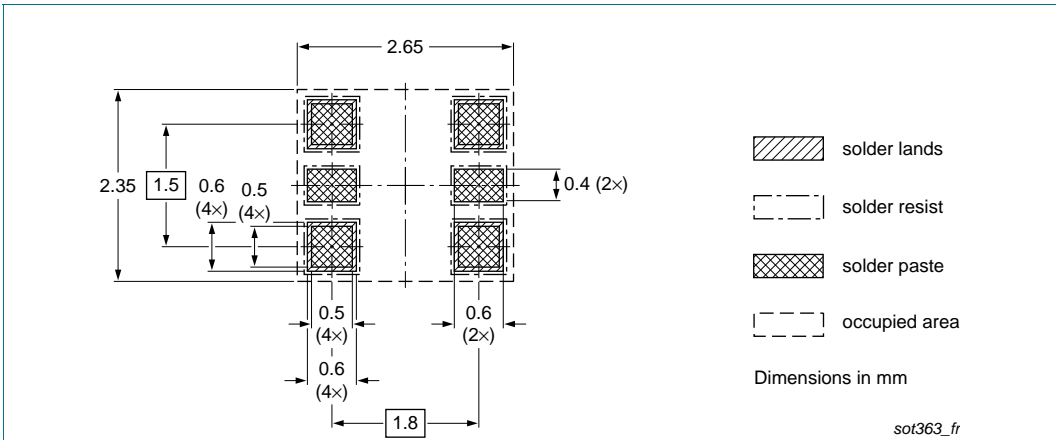


Fig 13. Reflow soldering footprint PUMH13 (SOT363)

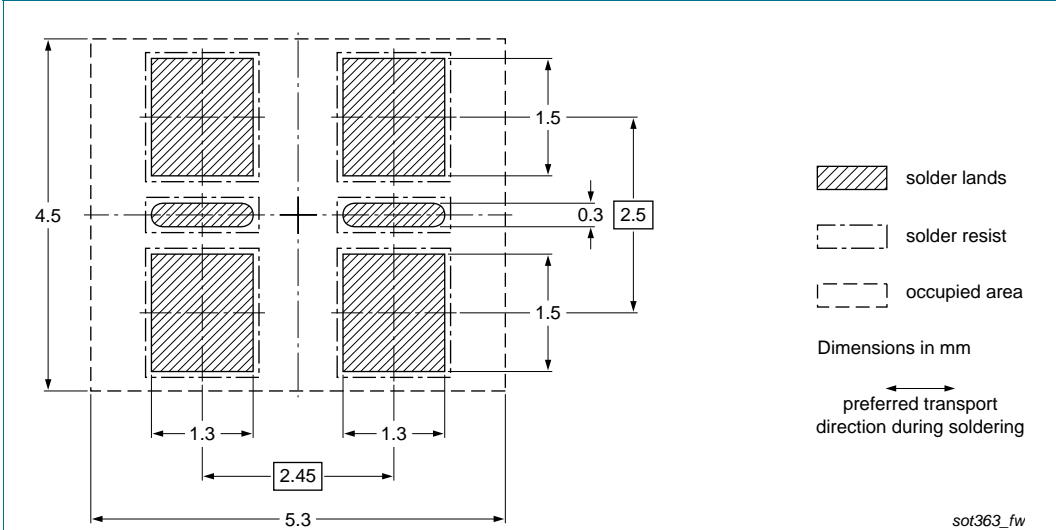


Fig 14. Wave soldering footprint PUMH13 (SOT363)
