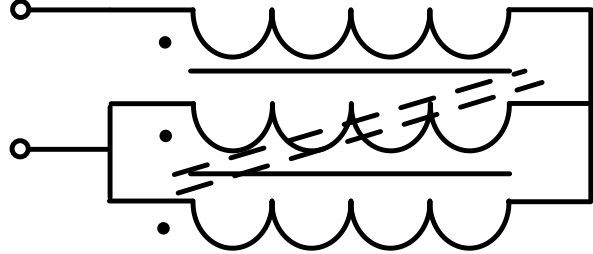

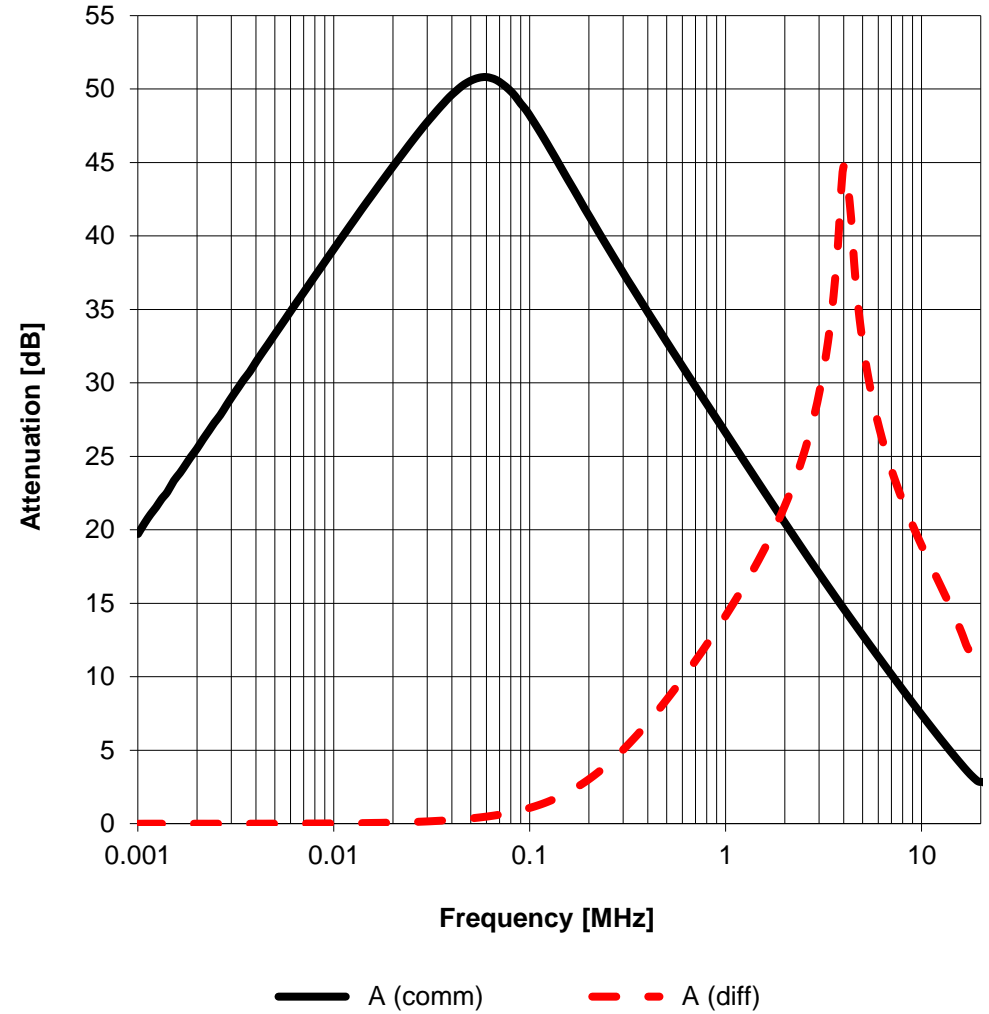
Common Mode


