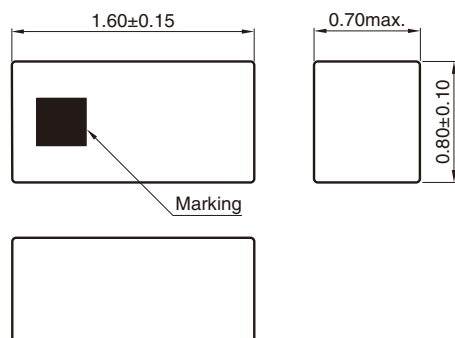

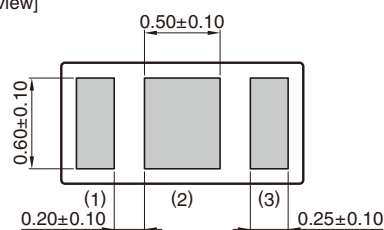

[Bottom view]

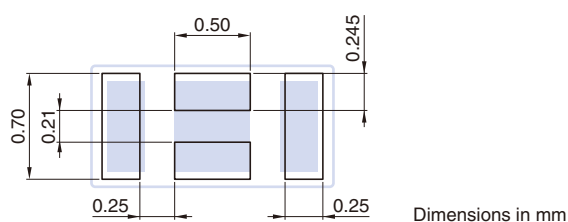

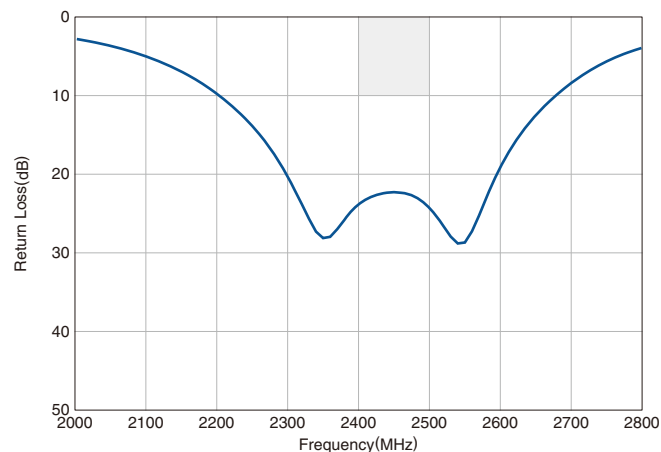
INSERTION LOSS

RETURN LOSS

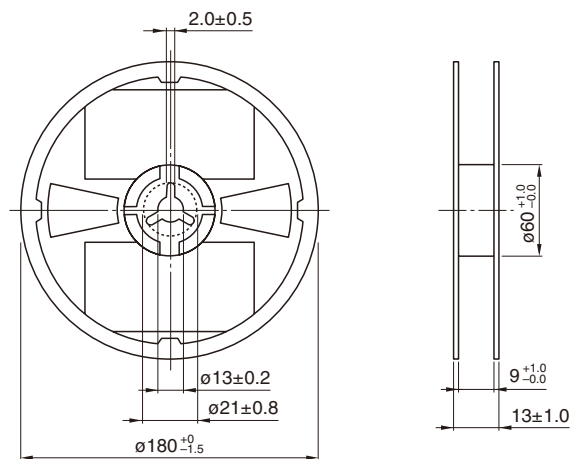

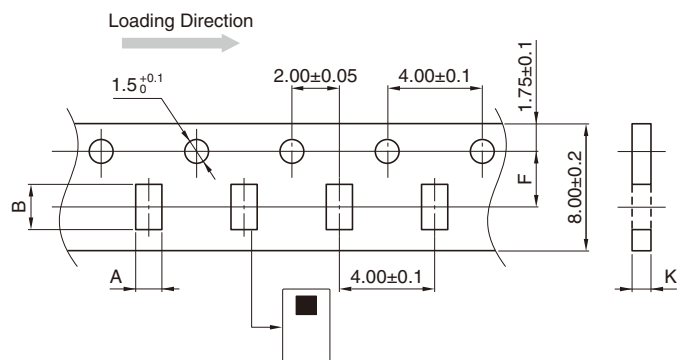

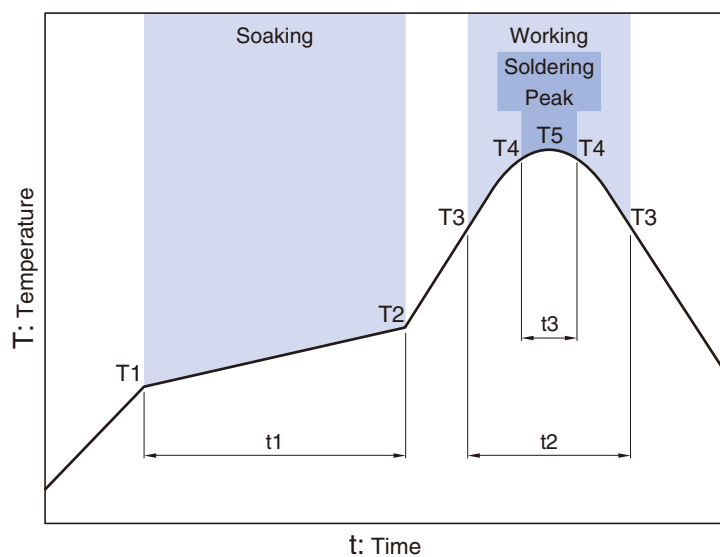
