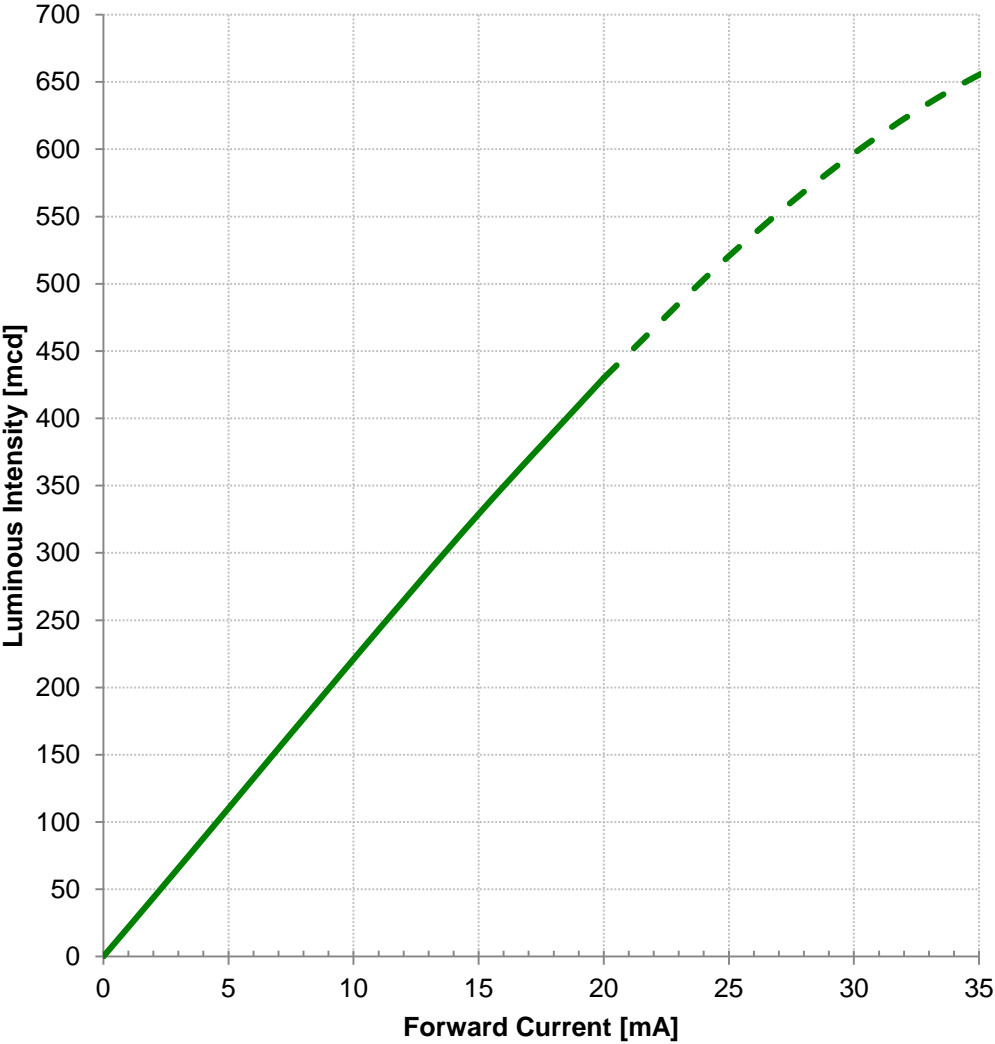
Forward Current vs. Forward Voltage:



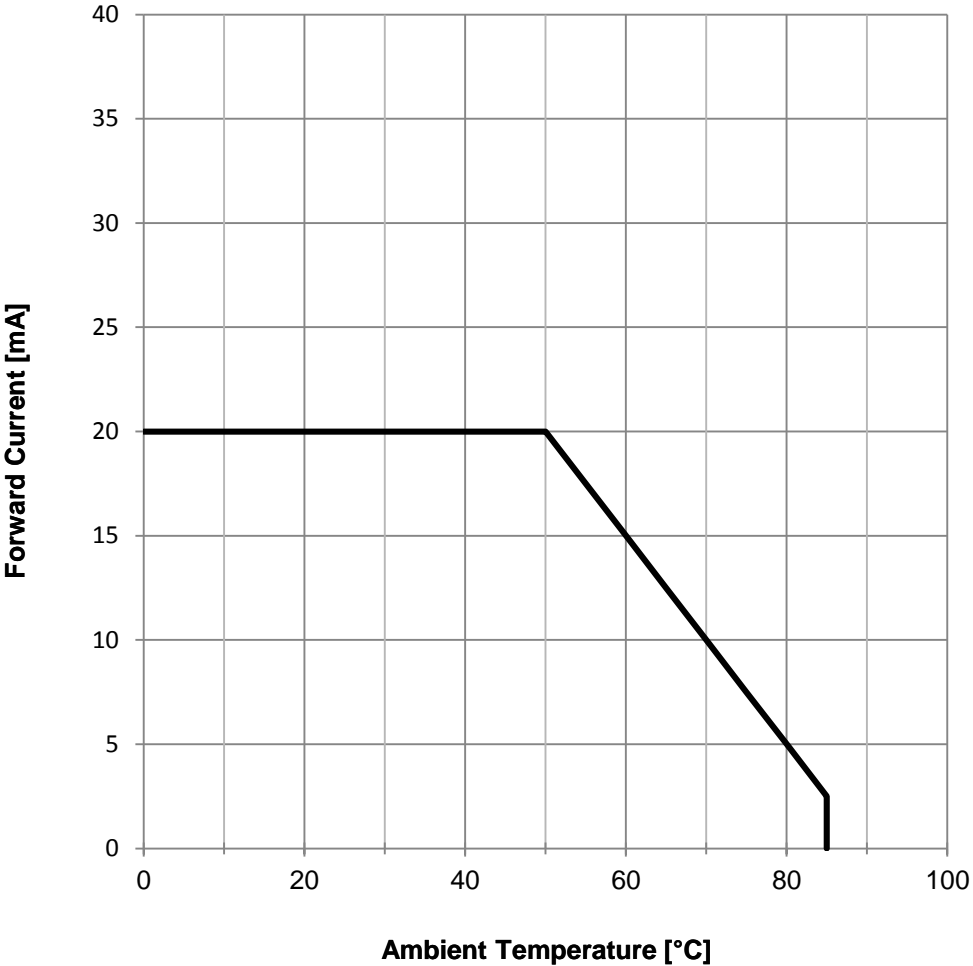



Luminous Intensity vs. Forward Current:



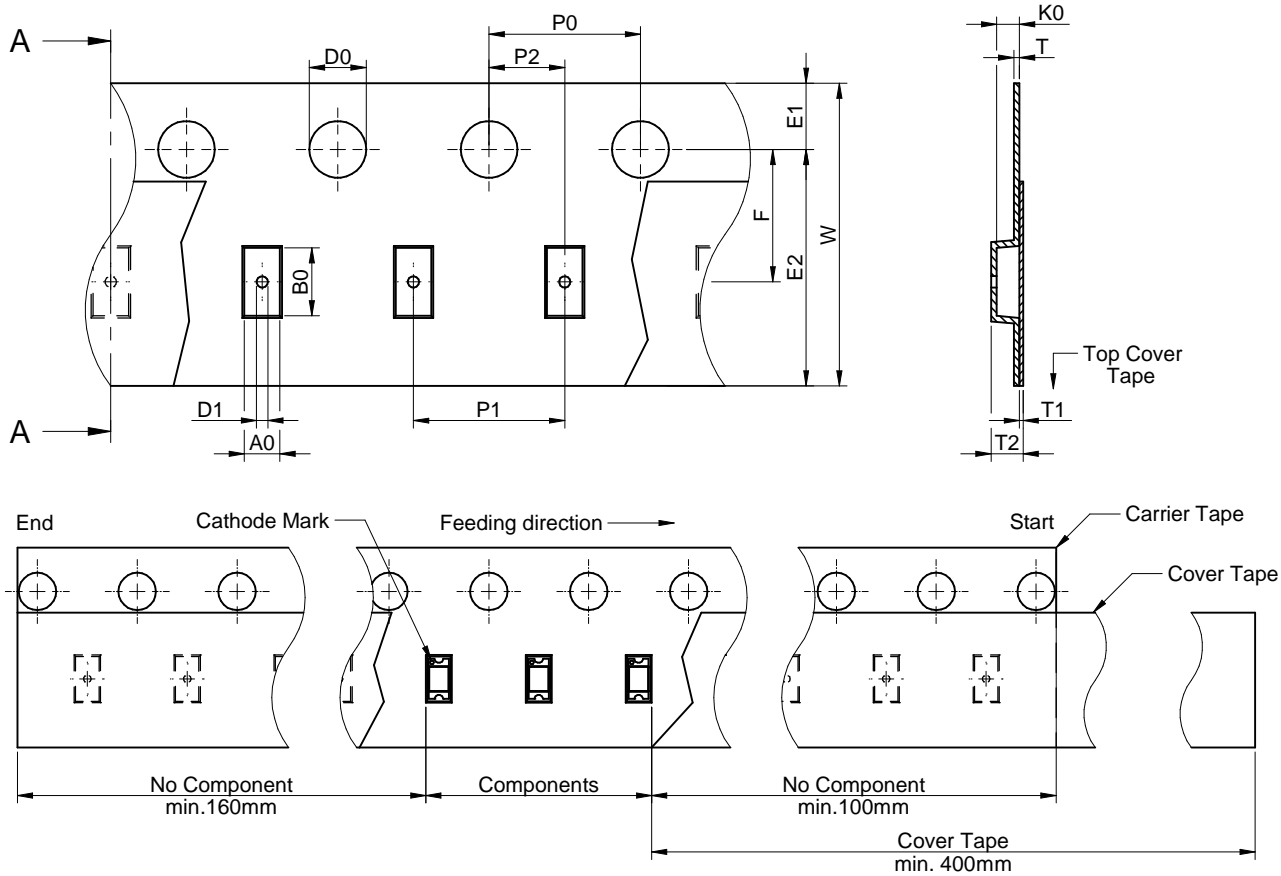
Derating Curve:



### Product specific:


