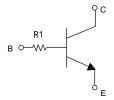

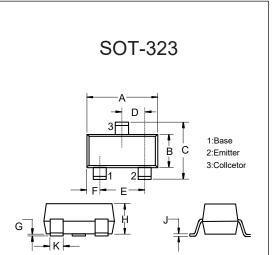

Internal Structure



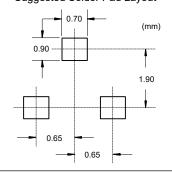
C:Collcetor E:Emitter

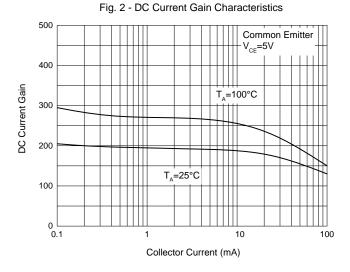

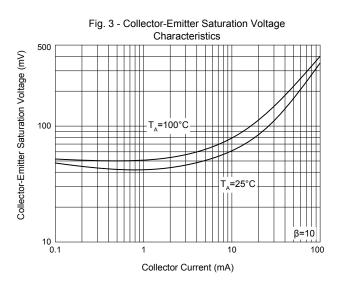

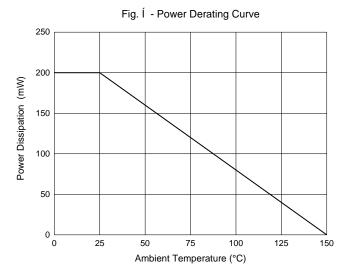
Fig. 1 - Static Characteristics COMMON EMITTER T_A=25°C 18μΑ 16µA
